## Introduction

This document provides an overview of the official UEFA EURO 2020 broadcast partners (as well as the respective countries concerned) issuing, either directly or via an intermediary, UEFA EURO 2020 public screening licences. This means that in the territories listed UEFA EURO 2020 public screening licences must be requested to the issuing entity indicated below and not to UEFA.

It is important to note that in these countries different screening terms and conditions as well as difference licence fees may apply. The relevant information provided by or on behalf of UEFA applies to those countries where UEFA issues public screening licences directly. For any query on applicable terms and conditions as well as fees in the countries where UEFA EURO 2020 public screening licences are not issued by UEFA, you will need to contact the relevant issuing entity for the respective countries listed below.
