AEK Athens FC

Charges:

- Violation of the UEFA Return to Play Protocol (team official delegation, obligation to wear a face mask), para. 11.2; (zoning access and movement on matchday), para. 14.2.3

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine AEK Athens FC €5,000 for the violation of the UEFA Return to Play Protocol.
- The above fine must be paid within 90 days of communication of this decision.

Date: 1 October 2020

Match: **Rangers FC** vs. Galatasaray A.Ş. (2:1)

Rangers FC

Charges:

- Violation of the UEFA Return to Play Protocol (accreditation system application), para 14.3.1

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine Rangers FC €5,000 for the violation of the UEFA Return to Play Protocol.
- The above fine must be paid within 90 days of communication of this decision.

Date: 20 October 2020

Match: **Stade Rennais FC** vs. FC Krasnodar (1:1)

Stade Rennais

Charges:

- Unsporting conduct (Mr. Steven Nzonzi), Art. 15(1)(a)(v) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To suspend Stade Rennais FC player, Mr. Steven Nzonzi, for a total of one (1) UEFA club competition match for which he would otherwise be eligible, for unsporting conduct.
- Stade Rennais FC ensures that the player is personally informed of this decision.

Competition: 2021 UEFA Nations League

Date: 11 October 2020

Match: **Serbia** vs. Hungary (0:1)

Serbia

Charges:

- Late kick-off, Art. 11(2)(h) DR
- Late kick-off (Mr. Ljubisa Tumbakovic), Art. 11(2)(h) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine Football Association of Serbia €20,000 for being responsible for the late kick-off.
- To order the enforcement of the suspended disciplinary measure imposed by the Control, Ethics and Disciplinary Body in its decision of 12 December 2019 (i.e. the suspension of Football Association of Serbia's coach, Mr. Ljubisa Tumbakovic for one (1) UEFA competition match in which he would otherwise participate), in accordance with Article 26(3) of UEFA Disciplinary Regulations, and to fine Football Association of Serbia's coach, Mr. Ljubisa Tumbakovic, €5,000 for being responsible for the late kick-off.
- The above fines must be paid within 90 days of communication of this decision.
- Football Association of Serbia ensures its head coach is personally informed of this decision.

Match: **Montenegro** vs. **Luxembourg** (1:2)

Montenegro

Charges:

- Improper conduct of the team, Art. 15(4) DR
- Assault (Mr. Janković Marko), Art. 15(1)(e) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine the Football Association of Montenegro € 9,000 for the improper conduct of the team.
- The above fine must be paid within 90 days of communication of this decision.
- To suspend the Football Association of Montenegro player, Mr. Janković Marko, for a total of two (2) UEFA national team competition matches for which he would be otherwise eligible, for assaulting another player.
- The Football Association of Montenegro ensures that its player is personally informed of this decision.

Luxembourg

Charges:

- Assault (Mr. Thill Olivier), Art. 15(1)(e) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To suspend the Luxembourg Football Federation player, Mr. Thill Olivier, for a total of two (2) UEFA national team competition matches for which he would be otherwise eligible, for assaulting another player.
- The Luxembourg Football Federation ensures that its player is personally informed of this decision.

Match: Greece vs. **Kosovo** (0:0)

Kosovo

Charges:

- Abusive language at a match official (Benjamin Kololli), Art. 15(1)(b) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To suspend Football Federation of Kosovo player, Mr. Benjamin Kololli, for a total of two (2) UEFA competition matches for which he would otherwise be eligible, for directing abusive language at a match official.
- The football Federation of Kosovo ensures that the player is personally informed of this decision.

Date: 14 October 2020

Match: **England** vs. Denmark (0:1)

England

Charges:

- Abusive language at a match official (James Reece), Art. 15(1)(b) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To suspend English Football Association player, Mr. James Reece, for a total of two (2) UEFA competition matches for which he would otherwise be eligible, for directing abusive language at a match official.
- The English Football Association ensures that the player is personally informed of this decision.

2021 UEFA European Under-21 Championship

Competition: 2021 UEFA European Under-21 Championship

Date: 8 October 2020

Match: **Kazakhstan** vs. North Macedonia (1:4)

Kazakhstan

Charges:

- Rough play (Mr. Orynassar Rauan), Art. 15(1)(a)(ii) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To suspend Kazakhstan Football Federation player, Mr. Orynassar Rauan, for a total of two (2) UEFA competition matches (including any matches previously and automatically served by the player to date) for which he would be otherwise eligible, for rough play.
- Kazakhstan Football Federation ensures that the player is personally informed of this decision.

Competition: 2021 UEFA European Under-21 Championship

Date: 8 October 2020

Match: Montenegro vs. **Israel** (1:2)

Israel

Charges:

- Assault (Mr. Shlomo Raz), Art.15(1)(e) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To suspend Israel Football Association player, Mr. Shlomo Raz, for a total of three (3) UEFA competition matches (including any matches previously and automatically served by the player to date) for which he would be otherwise eligible, for assaulting another player.
- Israel Football Association ensures that the player is personally informed of this decision.
