Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine FC Porto €40,000 for being responsible for the late kick-off.
- The above fine must be paid within 90 days of communication of this decision.
- To close the proceedings opened against FC Porto coach, Mr. Sergio Paulo Marceneiro Da Conceição, for being responsible of the late kick-off.
- FC Porto ensures that its coach is personally informed of this decision.

Maccabi Tel-Aviv FC

Charges:

- Late kick-off, Art. 11(2)(h) DR
- Late kick-off (Mr. Georgios Donis), Art. 11(2)(h) DR
- Rough play (Mr. Saborit Enric), Art. 15(1)(a)(ii) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine Maccabi Tel-Aviv FC €10,000 for being responsible for the late kick-off.
- The above fine must be paid within 90 days of communication of this decision.
- To warn Maccabi Tel-Aviv FC coach, Mr. Georgios Donis, for being responsible for the late kick-off.
- To suspend Maccabi Tel-Aviv player, Mr. Saborit Enric, for a total of one (1) UEFA club competition match for which he would otherwise be eligible, for rough play.
- Maccabi Tel-Aviv ensures that both its coach and player are personally informed of this decision.

The Control, Ethics and Disciplinary Body has decided:

- To fine Granada Club de Futbol €5,000 for breaching the UEFA Return to Play Protocol.
- The above fine must be paid within 90 days of communication of this decision.
- To warn Granada Club de Futbol for being responsible for the late kick-off.
- To warn Granada Club de Futbol head coach, Mr. Diego Martinez Penas, for being responsible for the late kick-off.
- Granada Club de Futbol ensures that its coach is personally informed of this decision.

Omonoia FC

Charges:

- Improper conduct of the team, Art. 15(4) DR
- Late kick-off, Art. 11(2)(h) DR
- Late kick-off (Mr. Henning Stille Berg), Art. 11(2)(h) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine Omonoia FC €7,000 for the improper conduct of its team.
- The above fine must be paid within 90 days of communication of this decision.
- To warn Omonoia FC for being responsible for the late kick-off.
- To warn Omonoia FC head coach, Mr. Henning Stille Berg, for being responsible for the late kick-off.
- Omonoia FC ensures that its coach is personally informed of this decision.

Qarabağ FK

Charges:

- Violation of the UEFA Return to Play Protocol, Para 11.2 (team official delegation, obligation to wear a face mask) and Para. 17.1.6 (media tribune, obligation to wear a face mask)

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine Qarabağ FK €5,000 for breaching the UEFA Return to Play Protocol.
- The above fine must be paid within 90 days of communication of this decision.

Match: **AZ Alkmaar** vs. Real Sociedad de Fútbol (0:0)

AZ Alkmaar

Charges:

- Improper conduct of the team, Art. 15(4) DR
- Setting off fireworks, Art. 16(2)(c) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine AZ Alkmaar €15,000 for setting off fireworks.
- To fine AZ Alkmaar €7,000 for the improper conduct of its team.
- The above fines in the total amount of €22,000 must be paid within 90 days of communication of this decision.

Match: Austria vs. **Northern Ireland** (2:1)

Northern Ireland

Charges:

- Directing abusive language at a match official (Mr. Austin Macphee), Art. 15(1)(b) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To suspend Irish Football Association assistant coach, Mr. Austin Macphee, for a total of two (2) UEFA competition matches for which he would otherwise be eligible, for directing abusive language at a match official.
- The Irish Football Association ensures that its assistant coach is personally informed of this decision.

Charges:

- UEFA Return to Play Protocol, para. 11.2 - team official delegation (accessing Zone 1); para. 14.3 - stadium access and accreditation management

The Control, Ethics and Disciplinary Body has decided:

- To fine the Football Association of Albania €5,000 for the violation of the UEFA Return to Play Protocol.
- The above fine must be paid within 90 days of communication of this decision.

Belarus

Charges:

- Improper conduct of the team, Art. 15(4) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine the Belarus Football Federation €6,000 for the improper conduct of its team.
- The above fine must be paid within 90 days of communication of this decision.

Charges:

- Violation of the UEFA Return to Play Protocol, para. 11.2 (team official delegation)

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine the Football Federation of North Macedonia €5,000 for the violation of the UEFA Return to Play Protocol.
- The above fine must be paid within 90 days of communication of this decision.

2021 European Under-21 Championship

Date: 12 November 2020

Match: **Scotland** vs. Croatia (2:2)

Scotland

Charges:

- Improper conduct of the team, Art. 15(4) DR
- Violation of the UEFA Return to Play Protocol, para. 14.2.3 (zoning access and movement on matchday)

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To warn the Scottish Football Association for the improper conduct of the team.
- To fine the Scottish Football Association €2,500 for the violation of the UEFA Return to Play Protocol.
- The above fine must be paid within 90 days of communication of this decision.

Competition: 2021 European Under-21 Championship

Date: 15 November 2020

Match: **Republic of Ireland** vs. Iceland (1:2)

Republic of Ireland

Charges:

- Assaulting another player (Mr. Collins Nathan Michael), Art. 15(1)(e) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To suspend Football Association of Ireland Under-21 player, Mr. Collins Nathan Michael, for a total of two (2) UEFA national team matches for which he would be otherwise eligible, for assaulting another player.
- The Football Association of Ireland ensures that the player is personally informed of this decision.
