Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine Villarreal CF €10,000 for being responsible for the late kick-off.
- The above fine must be paid within 90 days of communication of this decision.
- To suspend Villarreal CF coach, Mr. Unai Emery, for one (1) UEFA club competition match in which he would otherwise participate, for being responsible for the late kick-off. Said suspension is deferred for a probationary period of one (1) year, starting from the date of the present decision.
- Villarreal CF ensures that its coach is personally informed of this decision.
