Charges:

- Improper conduct of the team (5 players or more), Art. 15(4) DR
- Late handling of match sheet, Art. 40(3) of the Regulations of the UEFA Champions League 2020/21

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine FC Porto €16,000 for the improper conduct of the team.
- The above fine must be paid within 90 days of communication of this decision.
- To warn FC Porto for the late handling of the match sheet.

Date: 8 April 2021

Match: **AFC Ajax** vs. AS Roma (1:2)

AFC Ajax

Charges:

- Unsporting conduct of ball boys, Art. 11(1) and (2)(b) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To warn AFC Ajax for the unsporting conduct of the ball boys.

Competition: 2020/21 UEFA Europa League

Date: 8 April 2021

Match: **Granada CF** vs. Manchester United FC (0:2)

Granada CF

Charges:

- Invasion of the field of play, Art. 16(2)(a) DR
- Checking and guarding of the stadium, Art. 26 Safety & Security Regulations
- Protection of the playing area, Art. 40.01 Safety & Security Regulations

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine Granada CF €5,000 for the invasion of the field of play by one of its supporters.
- The above fine must be paid within 90 days of communication of this decision.
- To warn Granada CF for the insufficient checking and guarding of the stadium.
- To close the disciplinary proceedings opened against Granada CF for the alleged insufficient protection of the playing area.

Match: Villarreal CF vs. **Arsenal FC** (2:1)

Arsenal FC

Charges:

- Late kick-off, Art. 11(2)(h) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine Arsenal FC €15,000 for being responsible for the late-kick off.
- The above fine must be paid within 90 days of communication of this decision.

Competition: 2022 European Futsal Championship

Date: 7 April 2021

Match: **Albania** vs. Croatia (0:3)

Albania

Charges:

- Minimum medical requirements (i.e. emergency medical room and equipment), Arts. 13.01(i) and (l) UEFA Medical Regulations

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To warn the Albanian Football Association for failing to meet the minimum medical requirements, i.e. emergency medical room and equipment.

Competition: 2022 European Futsal Championship

Date: 9 April 2021

Match: **Montenegro** vs. Finland (1:2)

Montenegro

Charges:

- Minimum medical requirements - pitchside medical equipment, Arts. 10.02(f), 10.02(i) and 10.03(b) UEFA Medical Regulations

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To warn the Football Association of Montenegro for the violation of the minimum medical requirements.

Date: 13 April 2021

Match: Finland vs. **Belgium** (3:2)

Belgium

Charges:

- Rough play (Mr. Carello Aleixo Leonardo), Art. 15(1)(a)(ii) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To suspend Royal Belgian Football Association player, Mr. Carello Aleixo Leonardo, for one (1) UEFA representative team competition match for which he would be otherwise eligible, for rough play.
- The Royal Belgian Football Association ensures that the player is personally informed of this decision.

Match: **Moldova** vs. Slovakia (0:4)

Moldova

Charges:

- Improper conduct of the team, Art. 15(4) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine the Football Association of Moldova €2,700 for the improper conduct of the team.
- The above fine must be paid within 90 days of communication of this decision.

Competition: 2022 European Futsal Championship

Date: 14 April 2021

Match: **Romania** vs. North Macedonia (9:1)

Romania

Charges:

- Improper conduct of the team, Art. 15(4) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine the Romanian Football Federation €2,400 for the improper conduct of the team.
- The above fine must be paid within 90 days of communication of this decision.
