UEFA annual HatTrick solidarity and incentive payments 2021/22

Dear Sir or Madam,

In response to the COVID-19 pandemic, UEFA quickly adapted to its member associations' needs by allowing them flexibility in their use of the UEFA annual HatTrick solidarity and incentive payments for the 2020/21 season.

We hope that the 2021/22 season will see a return to normal. Under the terms of the *UEFA HatTrick V Regulations (Edition 2020)* and the enclosed guidelines, UEFA is pleased to confirm that the annual solidarity and incentive payments for the upcoming season will be made as follows.

First annual payment (see Art. 4, al. 2 b)

€1,230,000, due on 9 July 2021, will be automatically transferred to your association's bank account.

Second annual payment (see Art. 4, al. 2 b)

A maximum of €540,000 will be transferred to your association's bank account on 26 November 2021. The exact amount will depend on whether your national association has fulfilled the criteria and provided the requested documentation (cf. the enclosed guidelines). A detailed spreadsheet showing the exact amount that your association is entitled to receive will be sent out to general secretaries (with copy to HatTrick Programme coordinators) in November from UEFAHatTrick@uefa.ch.

Last annual payment (see Art. 4, al. 2 b)

The balance will be transferred to your association's bank account in June 2022. The exact amount will depend on whether your national association has fulfilled the criteria and provided the requested documentation (cf. the enclosed guidelines).

A credit advice, with a detailed spreadsheet showing the balance that your national association is entitled to receive, will be sent to general secretaries (with copy to HatTrick Programme coordinators) in May 2022 from UEFAHatTrick@uefa.ch.
