Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine FC Prishtina €5,000 for the violation of the UEFA Return to Play Protocol.
- The above fine must be paid within 90 days of communication of this decision.

Charges:

- Improper conduct of the team, Art. 15(4) DR

- To fine FC Prishtina €4,500 for the improper conduct of the team.
- The above fine must be paid within 90 days of communication of this decision.

Charges:

- Violation of the UEFA Return to Play Protocol, Article 14.1.2 (obligation to wear face masks), Article 14.2 (stadium zoning), Article 14.2.4 (zoning access and movement on matchday)

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine CFR 1907 Cluj €5,000 for the violation of the UEFA Return to Play Protocol.
- The above fine must be paid within 90 days of communication of this decision.

- To fine FC Levadia Tallinn €5,000 for failing to meet the minimum medical requirements, i.e. for the late arrival of the ambulance at the stadium.
- The above fine must be paid within 90 days of communication of this decision.

Charges:

- Improper conduct of the team (5 players or more), Art. 15(4) DR

- To warn FC Drita for the improper conduct of the team.

FK Dečić

Charges:

- Improper conduct of the team (6 or more players and officials), Art. 15(4) DR
- Assault (Mr. Dresaj Jonathan), Art. 15(1)(e) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To warn FK Dečić for the improper conduct of the team.
- To suspend FK Dečić player, Mr. Dresaj Jonathan, for a total of three (3) UEFA club competition matches for which he would otherwise be eligible, for assaulting another player.
- FK Dečić ensures that the player is personally informed of this decision.

- To fine NK Široki Brijeg €5,000 for the violation of the UEFA Minimum Health & Hygiene Requirements for the Return of Spectators.
- The above fine must be paid within 90 days of communication of this decision.

KF Vllaznia

Charges:

- Throwing of objects, Art. 16(2)(b) DR
- Violating the basic rules of decent conduct, Art. 11(2)(b) DR
- Violation of the UEFA Return to Play Protocol, Para. 11.2 (team official delegation)

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine KF Vllaznia €5,000 for the violation of the UEFA Return to Play Protocol.
- The above fine must be paid within 90 days of communication of this decision.
- To close disciplinary proceedings opened against KF Vllaznia for throwing of objects and for violating the basic rules of decent conduct.
