- Disturbances during the national anthems, Art. 16(2)(g) DR
- Setting of fireworks, Art. 16(2)(c) DR

Decision:

The Control, Ethics and Disciplinary Body decided on 10 July 2021:

- To fine the English Football Association €30,000 for the use of laser pointer, disturbances during the national anthems and setting of fireworks.
- The above fine must be paid within 90 days of communication of this decision.

Match: **Italy** vs. Spain (1:1)

Italy

Charges:

- Invasion of the field of play by its supporters, Art. 16(2)(a) DR

Decision:

The Control, Ethics and Disciplinary Body decided on 10 July 2021:

- To fine the Federazione Italiana Giuoco Calcio €5,000 for the invasion of the field of play by its supporters.
- The above fine must be paid within 90 days of communication of this decision.

UEFA EURO 2020 Final Tournament – Matchday 3

Match: **North Macedonia** vs. Netherlands (0:3)

North Macedonia

Charges:

- Violation of the UEFA Return to Play Protocol, Article 7.2 (sample collection)

Decision:

The Control, Ethics and Disciplinary Body decided on 10 July 2021:

- To fine the Football Federation of North Macedonia €10,000 for the violation of the UEFA Return to Play Protocol.
- The above fine must be paid within 90 days of communication of this decision.

Decision:

The Control, Ethics and Disciplinary Body decided on 9 July 2021:

- To combine the three disciplinary cases regarding Hungary and issue one comprehensive decision in accordance with Article 41(6) of the UEFA Disciplinary Regulations.
- To order the Hungarian Football Federation to play its next three (3) UEFA competition matches as host association behind closed doors, the third of which being suspended for a probationary period of two (2) years as from the date of the decision, for the discriminatory behaviour of its supporters.
- To order the Hungarian Football Federation to implement the following directive in the above-mentioned matches in which it will play as host association: to display a banner with the wording “#EqualGame”, with the UEFA logo on it.
- To fine the Hungarian Football Federation €100,000 for the discriminatory behaviour of its supporters.
- The above fine must be paid into the bank account within 90 days of communication of this decision.

Match: **Switzerland** vs. Spain (1:1)

Switzerland

Charges:

- Rough play (Mr. Remo Freuler), Art. 15(1)(a)(ii) DR
- Throwing of objects, Art. 16(2)(b) DR

Decision:

The Control, Ethics and Disciplinary Body decided on 6 July 2021:

- To suspend the Swiss Football Association player, Mr. Remo Freuler, for the next (1) representative team competition match for which he would be otherwise eligible, for rough play.
- The Swiss Football Association ensures that the player is personally informed of this decision.
- To fine the Swiss Football Association €10,250 for the throwing of objects by its supporters
- The above fine must be paid within 90 days of communication of this decision.

Match: **Sweden** vs. Ukraine (1:2)

Sweden

Charges:

- Rough play (Mr. Marcus Danielson), Art. 15(1)(a)(ii) DR

Decision:

The Control, Ethics and Disciplinary Body decided on 4 July 2021:

- To suspend the Swedish Football Association player, Mr. Marcus Danielson, for the next (1) representative team competition match for which he would be otherwise eligible, for rough play.
- The Swedish Football Association ensures that the player is personally informed of this decision.

Date: 28 June 2021

Match: **Croatia** vs. Spain (3:5)

- Invasion of the field of play by its supporters, Art. 16(2)(a) DR
- Throwing of objects, Art. 16(2)(b) DR

Decision:

The Control, Ethics and Disciplinary Body decided on 4 July 2021:

- To fine the Croatian Football Federation €30,000 for the throwing of objects by its supporters.
- To fine the Croatian Football Federation €5,000 for the pitch invasion by its supporters.
- The above fines in the total amount of €35,000 must be paid within 90 days of communication of this decision.

Match: **Netherlands** vs. Czech Republic (0:2)

Netherlands

Charges:

- Throwing of objects, Art. 16(2)(b) DR
- Denying an obvious goal scoring opportunity (Mr. Matthijs De Ligt), Art. 15(1)(a)(viii) DR

Decision:

The Control, Ethics and Disciplinary Body decided on 1 July 2021:

- To fine the Royal Netherlands Football Association €4'750 for the throwing of objects by its supporters.

- The above fine must be paid within 90 days of communication of this decision.
- To suspend Royal Netherlands Football Association player, Mr. Matthijs De Ligt, for a total of one (1) UEFA representative team competition match for which he would otherwise be eligible, for denying an obvious goal scoring opportunity.
- The Royal Netherlands Football Association ensures that the player is personally informed of the decision.

Match: **Wales** vs. Denmark (0:4)

Wales

Charges:

- Improper conduct of the team (5 players or more), Art. 15(4) DR
- Rough play (Mr. Harry Wilson), Art. 15(1)(a)(ii) DR

Decision:

The Control, Ethics and Disciplinary Body decided on 30 June 2021:

- To suspend the Football Association of Wales player, Mr. Harry Wilson, for the next (1) representative team competition match for which he would be otherwise eligible, for rough play.
- The Football Association of Wales ensures that Mr. Harry Wilson is personally informed of this decision.
- To warn the Football Association of Wales for the improper conduct of its team.

- Throwing of objects, Art. 16(2)(b) DR.

Decision:

- To fine the Football Association of Czech Republic €9,375 for the throwing of objects by its supporters.
- The above fine must be paid within 90 days of communication of this decision.

Match: Wales vs. **Denmark** (0:4)

Charges:

- Throwing of objects, Art. 16(2)(b) DR.

Decision:

The Control, Ethics and Disciplinary Body decided on 28 June 2021:

- To fine the Danish Football Association €35,000 for the throwing of objects by its supporters.
- The above fine must be paid within 90 days of communication of this decision.

Match: **Germany** vs. Hungary (2:2)

Germany

Charges:

- Invasion of the field of play, Art. 16(2)(a) DR.
- Disturbances during the national anthems, Art. 16(2)(g) DR

Decision:

The Control, Ethics and Disciplinary Body decided on 4 August 2021:

- To fine the Deutscher Fussball-Bund €8,000 for the invasion of the field of play and the disturbance during the national anthem.
- The above fine must be paid within 90 days of communication of this decision.

Date: 23 June 2021

Match: Slovakia vs. **Spain** (0:5)

Spain

Charges:

- Violation of the UEFA Return to Play Protocol, Para. 14.2.4 - zoning access and movement on matchday.

Decision:

The Control, Ethics and Disciplinary Body decided on 26 June 2021:

- To fine the Royal Spanish Football Federation €5,000 for the violation of the UEFA Return to Play Protocol.
- The above fine must be paid within 90 days of communication of this decision.

Date: 23 June 2021

Match: **Portugal** vs. **France** (2:2)

Portugal

Charges:

- Throwing of objects, Art. 16(2)(b) DR.

Decision:

The Control, Ethics and Disciplinary Body decided on 26 June 2021:

- To fine the Portuguese Football Federation €2'250 for the throwing of objects by its supporters.
- The above fine must be paid within 90 days of communication of this decision.

France

Charges:

- Throwing of objects, Art. 16(2)(b) DR.

Decision:

The Control, Ethics and Disciplinary Body decided on 26 June 2021:

- To fine the French Football Federation €21'750 for the throwing of objects by its supporters.
- The above fine must be paid within 90 days of communication of this decision.

Date: 23 June 2021

Match: Sweden vs. **Poland** (3:2)

Charges:

- Throwing of objects, Art. 16(2)(b) DR.

Decision:

The Control, Ethics and Disciplinary Body decided on 26 June 2021:

- To fine the Polish Football Association €4,125 for the throwing of objects by its supporters.
- The above fine must be paid within 90 days of communication of this decision.

Date: 21 June 2021

Match: **Finland** vs. Belgium (0:2)

Charges:

- Throwing of objects, Art. 16(2)(b) DR.

Decision:

The Control, Ethics and Disciplinary Body decided on 23 June 2021:

- To fine the Football Association of Finland €5,250 for the throwing of objects by its supporters.
- The above fine must be paid within 90 days of communication of this decision.

Date: 21 June 2021

Match: Russia vs. **Denmark** (1:4)

Denmark

Charges:

- Throwing of objects, Art. 16(2)(b) DR.

Decision:

The Control, Ethics and Disciplinary Body decided on 23 June 2021:

- To fine the Danish Football Association €6,750 for the throwing of objects by its supporters.
- The above fine must be paid within 90 days of communication of this decision.

Date: 20 June 2021

Match: Italy vs. **Wales** (1:0)

Wales

Charges:

- Rough play (Mr. Ethan Ampadu), Art. 15(1)(a)(ii) DR.

Decision:

The Control, Ethics and Disciplinary Body decided on 22 June 2021:

- To suspend Football Association of Wales player, Mr. Ethan Ampadu, for a total of one (1) UEFA representative team competition match for which he would otherwise be eligible, for rough play.
- The Football Association of Wales ensures that the player is personally informed of the decision.

Match: Spain vs. **Poland** (1:1)

Poland

Charges:

- Late kick-off, Art. 11(2)(h) DR.
- Late kick-off (Mr. Paulo Manuel Carvalho de Sousa), Art. 11(2)(h) DR.

Decision:

The Control, Ethics and Disciplinary Body decided on 21 June 2021:

- To warn the Polish Football Association for being responsible for the late kick-off.
- To warn Polish Football Association head-coach, Mr. Paulo Manuel Carvalho de Sousa, for being responsible for the late kick-off.
- The Polish Football Association ensures that its head-coach is personally informed of the decision.

Date: 19 June 2021

Match: **Hungary** vs. France (1:1)

Charges:

- Setting off fireworks, Art. 16(2)(c) DR.

Decision:

The Control, Ethics and Disciplinary Body decided on 21 June 2021:

- To fine the Hungarian Football Federation €3,500 for setting off fireworks.
- The above fine must be paid within 90 days of communication of this decision.

Date: 18 June 2021

Match: **Sweden** vs. Slovakia (1:0)

Sweden

Charges:

- Throwing of objects, Art. 16(2)(b) DR.

Decision:

The Control, Ethics and Disciplinary Body decided on 20 June 2021:

- To fine the Swedish Football Association €2,250 for the throwing of objects by its supporters.
- The above fine must be paid within 90 days of communication of this decision.

UEFA EURO 2020 Final Tournament – Matchday 1

Date: 15 June 2021

Match: **Hungary** vs. **Portugal** (0:3)

Hungary

Charges:

- Invasion of the field of play by its supporters, Art. 16(2)(a) DR.
- Setting off fireworks, Art. 16(2)(c) DR.

Decision:

The Control, Ethics and Disciplinary Body decided on 17 June 2021:

- To fine the Hungarian Football Federation €5,000 for the invasion of the field of play by one of its supporters.
- To fine the Hungarian Football Federation €2,000 for setting off fireworks.
- The above fines in the total amount of €7,000 must be paid within 90 days of communication of this decision.

Portugal

Charges:

- Crowd disturbances, Art. 16(2)(h) DR.

Decision:

The Control, Ethics and Disciplinary Body decided on 17 June 2021:

- To fine the Portuguese Football Federation €3,000 for the crowd disturbances by its supporters.
- The above fine must be paid within 90 days of communication of this decision.
