AC Sparta Praha

Charges:

- Racist behaviour, Art. 14(2) DR
- Provocative, offensive messages, Art. 16(2)(e) DR
- Throwing of objects, Art. 16(2)(b) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To order AC Sparta Praha to play its next (1) UEFA competition match as host club behind closed doors, for the racist behaviour of its supporters.
- To fine AC Sparta Praha €2,250 for the throwing of objects.
- The above fine must be paid within 90 days of communication of this decision.
- To close the proceedings opened against AC Sparta Praha for the alleged provocative offensive messages.

Match: **SK Slavia Praha** vs. **Ferencvárosi TC** (1:0)

SK Slavia Praha

Charges:

- Throwing of objects, Art. 16(2)(b) DR
- Provocative offensive messages, Art. 16(2)(e) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine SK Slavia Praha €10,000 for transmitting a provocative message of an offensive nature.
- To fine SK Slavia Praha €4,750 for the throwing of objects.
- The above fines in the total amount of €14,750 must be paid within 90 days of communication of this decision.

Ferencvárosi TC

Charges:

- Improper conduct of the team (5 players or more), Art. 15 (4) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine Ferencvárosi TC €7,500 for the improper conduct of the team.
- The above fine must be paid within 90 days of communication of this decision.

- To fine Legia Warszawa €14,000 for the blocking of public passageways.
- The above fine must be paid within 90 days of communication of this decision.
- To order a partial stadium closure of the Legia Warszawa stadium (i.e. the North Stand where the home supporters are seated) during the next UEFA club competition match in which Legia Warszawa will play as host club, for lighting of fireworks.

- To fine FC Urartu €2,500 for the violation of the UEFA Minimum Health & Hygiene Requirements for the Return of Spectators.
- The above fine must be paid within 90 days of communication of this decision.

- To warn KF Llapi 1932 for the improper conduct of the team.
- To suspend KF Llapi 1932 player, Mr. Benjamin Emin, for the next three (3) UEFA club competition matches for which he would be otherwise eligible, for assaulting another player.
- KF Llapi 1932 ensures that the player is personally informed of this decision.

- KÍ Klaksvík ensures that the coach is personally informed of this decision.
