Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine BSC Young Boys €3,375 for throwing of objects.
- To fine BSC Young Boys €15,750 for lighting of fireworks.
- To fine BSC Young Boys €18,000 for blocking of public passageways.
- To fine BSC Young Boys €10,000 for transmitting provocative messages of an offensive nature, i.e. for the illicit chants.
- The above fines in the total amount of €47,125 must be paid within 90 days of communication of this decision.

- To fine Celtic FC € 4,500 for the throwing of objects.

- To fine Galatasaray A.Ş. €5,000 for the invasion of the field of play.
- To fine Galatasaray A.Ş. €15,000 for crowd disturbances.
- The above fines in the total amount of €20,000 must be paid within 90 days of communication of this decision.

- To fine RSC Anderlecht €5,000 for the invasion of the field of play.
- To fine RSC Anderlecht €5,750 for throwing of objects.
- The above fines in the total amount of €10,750 must be paid within 90 days of communication of this decision.

Vitesse

Charges:

- Improper conduct of the team, Art. 15(4) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine Vitesse €4,500 for the improper conduct of the team.
- The above fine must be paid within 90 days of communication of this decision.

Charges:

- Lighting of fireworks, Art. 16(2)(c) DR

- To fine FC Basel 1893 €19,250 for lighting of fireworks.
- The above fine must be paid within 90 days of communication of this decision.

1. FC Union Berlin

Charges:

- Provocative, offensive message, Art. 16(2)(e) DR
- Lighting of fireworks, Art. 16(2)(c) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine 1. FC Union Berlin €11,000 for lighting of fireworks.
- To fine 1. FC Union Berlin €10,000 for transmitting a provocative message of an offensive nature.
- The above fines in the total amount of €21,000 must be paid within 90 days of communication of this decision.

Match: **Raków Częstochowa** vs. **KAAs Gent** (1:0)

Raków Częstochowa

Charges:

- Screening and searching of spectators, Article 33.02 SSR
- UEFA Minimum Health & Hygiene Requirements for the Return of Spectators, Article 8 (Queue management failure)

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To warn Raków Częstochowa for its failure to adequately screen and search spectators.
- To fine Raków Częstochowa €2,500 for the violation of the UEFA Minimum Health & Hygiene Requirements for the Return of Spectators.
- The above fine must be paid within 90 days of communication of this decision.

KAA Gent

Charges:

- Improper conduct of the team, Art. 15(4) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine KAA Gent €3,500 for the improper conduct of the team.
- The above fine must be paid within 90 days of communication of this decision.

Match: **Stade Rennais FC** vs. Rosenborg BK (2:0)

Stade Rennais FC

Charges:

- Wearable electronic performance and tracking systems, Article 43.01 UEFA Equipment Regulations
- Blocking of public passageways, Article 38 SSR
- UEFA Minimum Health & Hygiene Requirements for the Return of Spectators, Article 8 (Queue management); Article 9 (communication to spectators)
- Violation of the UEFA Return to Play Protocol, Article 14.2.1 (Stadium zones); Article 17.1.6 (Photographers during the match)

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To warn Stade Rennais FC for the violation of the UEFA Equipment Regulations.
- To fine Stade Rennais FC €18,000 for the blocking of public passageways.
- To fine Stade Rennais FC €6,000 for the violation of the UEFA Return to Play protocol.
- To fine Stade Rennais FC €5,000 for the violation of the UEFA Minimum Health & Hygiene Requirements for the Return of Spectators.
- The above fines in the total amount of €29,000 must be paid within 90 days of communication of this decision.
