PSV Eindhoven

Charges:

- Throwing of objects, Art. 16(2)(b) DR
- Lighting of fireworks, Art. 16(2)(c) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine PSV Eindhoven €1,500 for lighting of fireworks.
- To fine PSV Eindhoven €6,125 for throwing of objects.
- The above fines in the total amount of €7,625 must be paid within 90 days of communication of this decision.

Ferencvárosi TC

Charges:

- Improper conduct of the team (5 players or more), Art. 15(4) DR
- Blocking of public passageways, Art. 38 Safety and Security Regulations

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine Ferencvárosi TC €7,500 for the improper conduct of the team.
- To fine Ferencvárosi TC €20,000 for blocking of public passageways.
- The above fines in the total amount of €27,500 must be paid below within 90 days of communication of this decision.

GNK Dinamo

Charges:

- Lighting of fireworks, Art. 16(2)(c) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine GNK Dinamo €8,500 for lighting of fireworks.
- The above fine must be paid below within 90 days of communication of this decision.

FC Sheriff Tiraspol

Charges:

- Violating the basic rules of decent conduct (Mr. Georgios Athanasiadis), Art. 11(2)(b) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To reprimand FC Sheriff Tiraspol player, Mr. Georgios Athanasiadis, for violating the basic rules of decent conduct, i.e. for the damage caused to a door in the dressing room area of the GNK Dinamo Stadium.
- To order FC Sheriff Tiraspol player, Mr. Georgios Athanasiadis, to contact GNK Dinamo within 30 days for the settlement of the damages caused, i.e. the door in the dressing room area of the GNK Dinamo Stadium.
- FC Sheriff Tiraspol ensures that its player is personally informed of this decision.

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To close the proceedings against Brøndby IF for alleged blocking of public passageways.
- To fine Brøndby IF €13,000 for lighting of fireworks.
- To fine Brøndby IF €3,250 for throwing of objects.
- The above fines in the total amount of €16,250 must be paid within 90 days of communication of this decision.

Charges:

- Blocking of public passageways, Art. 38 Safety and Security Regulations
- Transmitting a provocative message of an offensive nature, Art. 16(2)(e) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine Legia Warszawa SA €14,000 for blocking of public passageways.
- To fine Legia Warszawa SA €15,000 for transmitting a provocative message of an offensive nature, i.e. illicit chants.
- The above fines in the total amount of €29,000 must be paid below within 90 days of communication of this decision.

SK Slavia Praha

Charges:

- Improper conduct of the team (5 players or more), Art. 15(4) DR
- Transmitting a provocative message of an offensive nature, Art. 16(2)(e) DR
- Insulting a match official (Mr. Hromada Jakub), Art. 15(1)(d) DR
- Rough play (Mr. Holeš Tomáš), Art. 15(1)(a)(ii) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To fine SK Slavia Praha €8,250 for the improper conduct of the team.
- To fine SK Slavia Praha €15,000 for transmitting a provocative message of an offensive nature.
- The above fines in the total amount of €23,250 must be paid below within 90 days of communication of this decision.
- To suspend SK Slavia Praha player, Mr. Hromada Jakub, for the next three (3) UEFA club competition matches for which he would be otherwise eligible, for insulting a match official.
- To suspend SK Slavia Praha player, Mr. Holeš Tomáš, for the next one (1) UEFA club competition match for which he would be otherwise eligible, for rough play.
- SK Slavia Praha ensures its players are personally informed of these decisions.

- To fine Royal Antwerp FC €5,250 for the improper conduct of the team.
- The above fines in the total amount of €15,375 must be paid below within 90 days of communication of this decision.

- To fine SK Sturm Graz €5,000 for the violations of the UEFA Return to Play Protocol.
- The above fines in the total amount of €13,000 must be paid below within 90 days of communication of this decision.

The Control, Ethics and Disciplinary Body has decided:

- To fine ŠK Slovan Bratislava €3,750 for throwing of objects.
- The above fine must be paid below within 90 days of communication of this decision.
- To suspend ŠK Slovan Bratislava player, Mr. Vernon De Marco, for the next three (3) UEFA club competition match for which he would be otherwise eligible, for assaulting another player.
- ŠK Slovan Bratislava ensures its player is personally informed of this decision.

- The above fines in the total amount of €9,000 must be paid below within 90 days of communication of this decision.

- The above fines in the total amount of €27,500 must be paid below within 90 days of communication of this decision.

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To declare the 2021/22 UEFA Women's Champions League match between Peamount United and FC Nike, that was initially scheduled to be played on 21 August 2021, as forfeited by FC Nike, who is therefore deemed to have lost the match 3-0 in accordance with Annex H.3.1 to the UEFA Women's Champion's League Regulations (2021/22 season).
