1. FC Union Berlin

Charges:

- Racist behaviour, Art. 14(1) and (2) DR

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To order a partial stadium closure of the 1. FC Union Berlin stadium (i.e. in sectors 13 and 14 where the home supporters are seated) during the next UEFA club competition match in which 1. FC Union Berlin will play as host club, for the racist behaviour of its supporters.
- To order 1. FC Union Berlin to implement the following directive in the next UEFA competition match in which it will play as host club: to display a banner with the wording “#NoToRacism”, with the UEFA logo on it, in the relevant closed sectors.

Azerbaijan

Charges:

- Responsibility for the matches not taking place, Art. 25.01 U17 Regulations

Decision:

The Control, Ethics and Disciplinary Body has decided:

- To declare the UEFA European Under-17 Championship 2022 match between the Under-17 national teams of the Association of Football Federations of Azerbaijan and the Football Association of Norway, that was scheduled to be played on 6 October 2021, as forfeited by the Association of Football Federations of Azerbaijan Under-17 national team (who is therefore deemed to have lost the match 0-3) for being responsible for the match not taking place (as provided for in Article 25.01 of the Regulations of the UEFA European Under-17 Championship 2021/22).
- To declare the UEFA European Under-17 Championship 2022 match between the Under-17 national teams of the Royal Belgian Football Association and the Association of Football Federations of Azerbaijan, that was scheduled to be played on 9 October 2021, as forfeited by the Association of Football Federations of Azerbaijan Under-17 national team (who is therefore deemed to have lost the match 3-0) for being responsible for the match not taking place (as provided for in Article 25.01 of the Regulations of the UEFA European Under-17 Championship 2021/22).
- To declare the UEFA European Under-17 Championship 2022 match between the Under-17 national teams of the Luxembourg Football Federation and the Association of Football Federations of Azerbaijan, that was scheduled to be played on 12 October 2021, as forfeited by the Association of Football Federations of Azerbaijan Under-17 national team (who is therefore deemed to have lost the match 3-0) for being responsible for the match not taking place (as provided for in Article 25.01 of the Regulations of the UEFA European Under-17 Championship 2021/22).
