UEFA European Under-19 Futsal Championship Final Tournament 2023 – Invitation to bid

Dear Sir or Madam,

We are pleased to invite all UEFA member associations to bid to host the final tournament of the UEFA Under-19 Futsal EURO 2023.

If your association is interested in hosting the final tournament, to be held in September 2023, and intends to submit a bid, we kindly ask you to confirm your interest by completing, signing and returning the attached declaration of interest form by **Wednesday, 29 March 2022, 12:00 CET**.

The UEFA Finals and Final Phases Bid Regulations approved on the 19 April 2021 by the UEFA Executive Committee apply. A digital version of these regulations is available on [UEFA Documents](#).

The bidding timeline is set out below. All dates are subject to final confirmation nearer the time:

15 November 2021	<i>Official invitation to bid sent out to UEFA member associations</i>
29 March 2022, 12:00 CET	<i>Deadline for national associations to confirm their interest to bid</i>
30 March 2022	<i>Bid requirements are made available to the bidders</i>
19 May 2022, 12:00 CET	<i>Preliminary bid dossier submission deadline</i>
4 July 2022, 12:00 CET	<i>Final bid dossier submission deadline</i>
21 September 2022	<i>Appointment of host of UEFA Under-19 Futsal EURO 2023</i>

The UEFA Under-19 Futsal EURO will be contested by eight teams with the appointed host association automatically qualifying. The key tournament requirements are as follows:

Arena

- One arena with minimum 2,500 spectators
- Minimum of four dressing rooms needed for teams and two for referees

Training halls

- Two training halls (with parquet wood) for teams with a maximum driving distance of 30 minutes.
- One training hall for referees

Hotels (ideal option)

- One hotel accommodating all eight teams, UEFA guests and staff
- One hotel accommodating the referees

Time period

- In principle, the final tournament will take place beginning of September 2023.

With regards to UEFA's financial contribution scheme, an event budget would be drawn up with the host association and covered by UEFA with financial elements to be disclosed in the staging agreement.
