- Forfeit (participation of a suspended player), Art. 27(2) DR in connection with Art. 47(1) Regulations of the UEFA Women's Under-17 Championship
 - To declare the UEFA Women's Under-17 Championship match Azerbaijan vs. North Macedonia played on 11 March 2022 as forfeit. Football Federation of North Macedonia's Women Under-17 team is deemed to have lost the match 3:0.
 - The Football Federation of North Macedonia's Women Under-17 player, Ms. Petkova Katerina still has to serve one UEFA competition match suspension for which she would be otherwise eligible.
 - Fine; €2,000

North Macedonia vs. Albania (2:4), 14 March 2022

North Macedonia

Incident and decision:

- Forfeit (participation of a suspended player), Art. 27(2) DR in connection with Art. 47(1) Regulations of the UEFA Women's Under-17 Championship
 - To declare the UEFA Women's Under-17 Championship match North Macedonia vs. Albania played on 14 March 2022 as forfeit. Football Federation of North Macedonia's Women Under-17 team is deemed to have lost the match 3:0.
 - The Football Federation of North Macedonia's Women Under-17 player, Ms. Petkova Katerina still has to serve one UEFA competition match suspension for which she would be otherwise eligible.
 - Fine: €2,000

Austria vs. Kosovo (2:4), 26 March 2022

Kosovo

Incident and decision:

- Assaulting another player (Ms. Eriola Delija), Art. 15(1)(e) DR
 - Suspension: next three (3) UEFA competition matches
