Amendments to the following regulations:

- **2022/23 UEFA European Women's Under-19 Championship (WU19)**
- **2022/23 UEFA European Under-19 Championship (U19)**
- **2022/23 UEFA Regions' Cup (UREG)**
- **2021–23 UEFA European Under-21 Championship (U21)**

Dear Sir or Madam,

In response to the COVID-19 pandemic, in May 2020 IFAB introduced a temporary amendment to Law 3 – The Players – on the maximum number of permitted substitutions.

The UEFA Executive Committee immediately introduced five substitutions plus one additional substitution during extra-time (5+1) for all its senior football competitions for the 2020/21 and 2021/22 seasons.

With the release of the 2022/23 IFAB Laws of the Game, this temporary amendment has been made permanent (Law 3, Paragraph 2), so that UEFA can now align the substitution quotas for all its competitions.

For the 2023 Under-21 final tournament, an additional set of articles will be introduced for a possible Olympic Games play-off match, following the confirmed qualification of France (Olympic host) and England (not registered for the Olympic Games).
