### 2023/24 UEFA Women's Champions League – match calendar and access list

Dear Sir or Madam,

We are pleased to provide you with the match calendar and access list for the 2023/24 UEFA Women's Champions League.

#### Match calendar 2023/24

For ease of reference, the match dates for the 2023/24 UEFA Women's Champions League are as follows:

<b>Preliminary round (if applicable)</b>	26/27 July (Wed/Thu) and 2/3 August 2023 (Wed/Thu)
<b>Round 1</b>	6 September (semi-finals) (Wed) and 9 September 2023 (final & 3rd place) (Sat)
<b>Round 2</b>	10/11 October (Tue/Wed) and 18/19 October 2023 (Wed/Thu)
<b>Group stage MD1</b>	14/15 November 2023 (Tue/Wed)
<b>Group stage MD2</b>	22/23 November 2023 (Wed/Thu)
<b>Group stage MD3</b>	13/14 December 2023 (Wed/Thu)
<b>Group stage MD4</b>	20/21 December 2023 (Wed/Thu)
<b>Group stage MD5</b>	24/25 January 2024 (Wed/Thu)
<b>Group stage MD6</b>	30/31 January 2024 (Tue/Wed)
<b>Quarter-finals</b>	19/20 (Tue/Wed) and 27/28 March 2024 (Wed/Thu)
<b>Semi-finals</b>	20/21 April (Sat/Sun) and 27/28 April 2024 (Sat/Sun)
<b>Final</b>	24, 25 or 26 May 2024 tbc (Fri, Sat or Sun)

Please note that the UEFA Women's Champions League calendar this season has been affected by the FIFA Women's World Cup, which ends on 20 August 2023. As a consequence, all rounds of the UEFA Women's Champions League as from round 1 have been pushed back by one month. We have consulted with our broadcaster, DAZN, different national associations/leagues and the European Club Association on calendar options, and while noting there may be some challenges in going into January with the group stage due to weather conditions, the benefits, such as a less congested calendar for leagues and therefore safeguarding players' welfare, outweigh such concerns.

We would also point out that the women's international windows for 2024 onwards are still to be confirmed by FIFA. Given the pressing need to publish the 2023/24 calendar in order to support leagues, clubs and other stakeholders with the planning of their seasons, the UEFA calendar has been drawn up with provisional 2024 international windows based on similar timings and lengths as those in the women's international calendar 2020-2023. The 2023/24 UEFA women's match calendar available on <http://www.uefa.com/womenschampionsleague/about/> will be finalised once the 2024 FIFA women's international match calendar has been published.

### Provisional 2023/24 access list

Please find enclosed the provisional access list that indicates the number of clubs each association is entitled to enter in the 2023/24 UEFA Women's Champions League. The 2023/24 access list is based on 52 associations entering clubs in the competition, with the positions of the associations in the access list determined on the basis of the five-season association coefficients established at the end of the 2021/22 season, i.e. the cumulative total of each association's season coefficient from the 2017/18 season to the 2021/22 season inclusive.

Note that as all Russian teams and clubs are currently suspended from UEFA competitions until further notice, in accordance with the decision taken by the UEFA Executive Committee on 28 February 2022 (see Circular Letter No. 21/2022; and as confirmed by the Court of Arbitration for Sport on 15 July 2022), an updated version of the provisional access list for the 2023/24 season may be communicated in due course before the end of the 2022/23 season.

The definitive access list will only be sent in June 2023, once the final number of entries for the competition and the 2023 titleholder are known.

The calendar and access list will be incorporated in the Regulations of the UEFA Women's Champions League 2023/24, which will be subject to the UEFA Executive Committee's approval.

### Registration procedure

Registration for the competition will be made in two stages. There will be a pre-registration mid-May 2023 to check the eligibility of each participating club, followed by the final registration at the beginning of June 2023. This deadline will be extended to 19 June (latest) for those leagues concluding in the first half of June. Please also note that to be eligible to participate in the competition, clubs must have obtained a licence issued by the competent national body in accordance with the UEFA Club Licensing Regulations for the UEFA Women's Champions League and be included in the list of licensing decisions to be submitted by this body to the UEFA administration by the 31 May 2023 deadline.
