 - > Fine: €10,000

- Throwing of objects, Art. 16(2)(b) DR
- Lighting of fireworks, Art. 16(2)(c) DR
- Act of damage, Art. 16(2)(f) DR
- Crowd disturbances, Art. 16(2)(h) DR
 - > Fine: €50,000
 - > Ban from selling tickets to its away supporters for its next two (2) UEFA competition matches
 - > The ban from selling tickets to its away supporters for the second match is suspended during a probationary period of two (2) years
 - > Contact SK Sturm Graz within 30 days for the settlement of damages
