 - Partial stadium closure during the next UEFA competition match. Said partial stadium closure is suspended for a probationary period of two (2) years.

 - > Fine: €18,000
- Throwing of objects, Art. 16(2)(b) DR
 - ➤ Fine: €57,750
- Lighting of fireworks, Art. 16(2)(c) DR
 - ➤ Fine: €3,500
- Blocking of public passageways, Art. 38 SSR
 - Fine: €22,000

ACF Fiorentina vs. Sivasspor (1:0), 9 March 2023

 - Warning
- Blocking of public passageways, Art. 38 SSR
 - > Fine: €8,000
- Lighting of fireworks, Art. 16(2)(c) DR
 - > Fine: €7,250

Incident and decision:

- Assault (Mr. Gradel Max Alain), Art. 15(1)(e) DR
 - > Suspension: three (3) UEFA club competition matches

- Blocking of public passageways, Art. 38 SSR
 - > Fine: €24,000
- Throwing of objects, Art. 16(2)(b) DR
 - > Fine: €20,000
 - > Partial stadium closure during the next UEFA competition match. Said partial stadium closure is suspended during a probationary period of two (2) years.

AEK Larnaca FC vs. West Ham United FC (0:2), 9 March 2023

Incident and decision:

- Lighting of fireworks, Art. 16(2)(c) DR
 - > Fine: €30,000
 - Partial stadium closure during the next (1) UEFA competition match. Said partial stadium closure is suspended for a probationary period of two (2) years.

West Ham United FC

Incident and decision:

- Throwing of objects, Art. 16(2)(b) DR
 - > Fine: €3,750

Sivasspor vs. ACF Fiorentina (1:4); 16 March 2023

Sivasspor

Incidents and decision:

- Invasion of the field of play, Art. 16(2)(a) DR
- Crowd disturbances, Art. 16(2)(h) DR
- Insufficient protection of the playing area against intruders, Art. 40.01 SSR
 - > Match behind closed doors during the next UEFA club competition match
- Assault (Mr. Arslan Hakan), Art. 15(1)(e) DR
 - Suspension: three (3) UEFA club competition matches

Liverpool FC Youth vs. FC Porto Youth (1:1), 1 March 2023

FC Porto Youth

- Assault (Mr. Azevedo Ribeiro Gonçalo Miguel), Art. 15(1)(e) DR
 - Suspension: two (2) UEFA club competition matches
- Assault (Mr. Candé Umaro), Art. 15(1)(e) DR
 - > Suspension: two (2) UEFA club competition matches
- Repeated protests against the referee's orders (Mr. Silva Rui Miguel Cruz), Art. 15(1)(a)(iii) DR
 - > Suspension: one (1) UEFA club competition match
