## Preamble

The following regulations have been adopted on the basis of Articles 49(2)(a) and 50(1) of the *UEFA Statutes*.

---

# I General Provisions

---

## Article 1 Scope of application and aims of the competition

---

- 1.01 The present regulations govern the rights, duties and responsibilities of all parties participating and involved in the preparation and organisation of the 2022/23 UEFA Regions' Cup (hereinafter the competition).
- 1.02 By adopting the present regulations, UEFA intends to:
- accord, at national and international level, greater importance to amateur football, which is recognised as an important pillar of European football;
  - encourage UEFA's member associations to stage domestic competitions for regional amateur representative teams;
  - offer young players who have had to leave the youth sector for age reasons and who cannot make the leap to the professional sector an incentive to stay faithful to football and not move to another sporting discipline;
  - offer a special football experience to players who would otherwise not have the opportunity to compete in international competitions;
  - improve standards at grassroots level (amateur football);
  - organise international football festivals to promote regional contacts, reciprocal understanding and acceptance, and greater knowledge of other cultures and regions;
  - encourage the exchange of interpersonal, cultural and sporting values.

---

## Article 2 Definitions

---

- 2.01 In the context of these regulations, the following definitions apply:
- commercial rights: any and all commercial rights and opportunities in and in relation to the competition including media rights, marketing rights and data rights;
  - data rights: the right to compile and exploit statistics and other data in relation to the competition;
  - doping: the occurrence of one or more of the anti-doping rule violations set out in the *UEFA Anti-Doping Regulations*;
  - host association: the association organising a qualifying match or the association designated by UEFA to stage the final tournament;
  - marketing rights: the right to advertise, promote, endorse and market the competition; to conduct public relations activities in relation to the competition; and to exploit all advertising, sponsorship, hospitality, licensing, merchandising, publishing, betting, gaming, retailing, music and franchising opportunities and all other commercial association rights (including through ticket promotions) in relation to the competition;

- f. media rights: the right to create, distribute and transmit on a linear and/or on-demand basis for reception at any time including on a live and/or delayed basis anywhere in the world by any and all means and in any and all media, whether now known or devised in the future (including all forms of television, radio, mobile, wireless and internet distribution), digital, audiovisual, visual and/or audio coverage of the competition and all associated and/or related rights, including fixed media, download and interactive rights.

- 2.02 In the context of these regulations, any phrase introduced by the terms "including", "include", "in particular", "for example" or any similar expression is illustrative and does not limit the sense of the words preceding those terms.

---

### Article 3 Frequency and entries for the competition

---

- 3.01 UEFA stages the competition every two years.
- 3.02 Every UEFA member association (hereinafter association) may enter one regional or, where applicable, one national amateur representative team for the competition.

---

### Article 4 Admission criteria and procedure

---

- 4.01 To be eligible to participate in the competition, associations must:
- a. confirm in writing, where applicable, that their team has qualified through a national qualifying competition;
  - b. confirm in writing that they themselves, as well as their players and officials, comply with the *IFAB Laws of the Game* promulgated by the International Football Association Board (IFAB) and agree to respect the statutes (including the principles of fair play as defined therein), regulations, protocols, directives and decisions of UEFA;
  - c. confirm in writing that they themselves, as well as their players and officials, agree to recognise the jurisdiction of the Court of Arbitration for Sport (CAS) in Lausanne, Switzerland, as defined in the relevant provisions of the *UEFA Statutes* and agree that any proceedings before the CAS concerning admission to, participation in or exclusion from the competition will be held in an expedited manner in accordance with the *CAS Code of Sports-related Arbitration* and with the directions issued by the CAS, including for provisional or super-provisional measures, to the explicit exclusion of any state court;
  - d. fill in the official entry documents (i.e. all documents containing the information deemed necessary by the UEFA administration for ascertaining compliance with the admission criteria), which must reach the UEFA administration within the deadline set by the latter and communicated in due course through a circular letter sent to all associations.
- 4.02 The UEFA administration decides on admission to the competition. Such decisions are final.



---

## Article 5 Duties of the associations

---

- 5.01 On entering the competition, participating associations and their qualified teams agree:
- a. to play in the competition until their elimination and to field their strongest team throughout the competition;
  - b. to stage and play all matches in the competition in accordance with the present regulations;
  - c. to comply with all decisions regarding the competition taken by the UEFA Executive Committee, the UEFA administration or any other competent body and communicated appropriately (by UEFA circular letter or by official letter or email);
  - d. to observe the *UEFA Safety and Security Regulations* for all matches in the competition;
  - e. to stage each match in the competition in a stadium meeting the structural criteria of the stadium category required by [Paragraph 25.01](#);
  - f. to indemnify, defend and hold UEFA, its subsidiaries and any LOS (local organising structure) and all of their officers, directors, employees, representatives, agents and other auxiliary persons free and harmless against any and all liabilities, obligations, losses, damages, penalties, claims, actions, fines and expenses (including reasonable legal expenses) of whatsoever kind or nature resulting from, arising out of, or attributable to any non-compliance by the association or any of its players, officials, employees, representatives or agents with these regulations;
  - g. not to represent UEFA or the competition without UEFA's prior written approval.

---

## Article 6 Responsibilities of the associations

---

- 6.01 If necessary, associations must apply for visas from the diplomatic mission of the host country well in advance of the relevant tournament.
- 6.02 The associations are responsible for the behaviour of their players, officials, members, supporters and any person carrying out a function at a match on their behalf.
- 6.03 Matches must be played in stadiums within the territory of the host association. Exceptionally, matches may be played in the territory of another UEFA member association, if so decided by the relevant UEFA bodies, for instance for reasons of safety or as a result of a disciplinary measure.
- 6.04 The host association is responsible for safety and security before, during and after the match. The host association may be called to account for incidents of any kind and may be disciplined.
- 6.05 Minimum medical requirements concerning the provision of facilities, equipment and personnel by the host association are set out in the *UEFA Medical Regulations*. For the avoidance of doubt, the host association has sole responsibility for the provision and operation of any facilities and equipment required in the above-mentioned regulations.

- 
- 6.06 The UEFA administration informs the associations participating in the final tournament about any further guidelines, directives or decisions related to that stage of the competition and provides them with all relevant documents in due time.

---

#### Article 7 Anti-doping

---

- 7.01 Doping is forbidden and is a punishable offence. In case of anti-doping rule violations, UEFA will instigate disciplinary proceedings against the perpetrators and take the appropriate disciplinary measures in accordance with the *UEFA Disciplinary Regulations* and *UEFA Anti-Doping Regulations*. This may include the imposition of provisional measures.
- 7.02 UEFA may test any player at any time.

---

#### Article 8 Fair play

---

- 8.01 All UEFA competition matches must be played in accordance with the principles of fair play as defined in the *UEFA Statutes*.
- 8.02 Fair play assessments are conducted at all matches in the competition in accordance with the *UEFA Fair Play Regulations*, in order to establish association fair play rankings at the end of each season.
- 8.03 A fair play competition is also conducted among the associations that qualify for the final tournament, on the basis of their fair play assessments in the qualifying competition and the final tournament.

---

#### Article 9 Insurance

---

- 9.01 All persons involved in the competition are responsible for their own insurance cover.
- 9.02 The participating associations are responsible for and undertake to conclude all necessary and adequate insurance cover for their delegations, including players and officials, at their own expense for the whole duration of the competition.
- 9.03 Host associations staging matches and/or tournaments in the competition must conclude appropriate insurance cover with reputable insurers for all of their risks arising under these regulations at their own expense, in accordance with their responsibilities, as set out in [Article 6](#) of these regulations and in the staging agreement in the case of the final tournament. The third-party liability policy must include an appropriate guaranteed sum for damages to persons, objects and property, as well as for pure economic losses corresponding to the specific circumstances of the associations concerned. Likewise, the policies must fully cover all risks connected with the staging of the matches or tournaments in question (including force majeure events). In any case, host associations must ensure that UEFA is included as co-insured party in all insurance policies as defined in the present paragraph.

- 9.04 The host association must ensure that the owners and/or operators of all official sites, including stadiums, provide fully comprehensive insurance cover, including third-party liability and property damage. If appropriate insurance policies are not provided in due time by the owner and/or operator of an official site, the host association is required to conclude the necessary additional insurance cover at its own cost, failing which it may be concluded by UEFA at the host association's expense.
- 9.05 Claims for damages against UEFA are expressly excluded and anyone involved must hold UEFA harmless from any and all claims for liability arising in relation to the competition. In any case, UEFA may request anyone involved to provide, free of charge, written releases of liability, hold harmless notes, confirmation and/or copies of the policies concerned in one of UEFA's official languages.

---

## Article 10 Trophy, plaques and medals

---

- 10.01 The original trophy, which is used for the official presentation ceremony at the final and at other official events approved by UEFA, remains in UEFA's keeping and ownership at all times. A full-size replica trophy, the UEFA Regions' Cup winners' trophy, is awarded to the winning association.
- 10.02 Replica trophies awarded to winners of the competition (past and current) must remain within the relevant association's control at all times and may not leave the association's country without UEFA's prior written consent. Associations must not permit a replica trophy to be used in any context where a third party (including their sponsors and other partners) is granted visibility or in any other way which could lead to an association between any third party and the trophy and/or the competition. Associations must comply with any trophy use guidelines that the UEFA administration may issue from time to time.
- 10.03 Associations may not, and may not permit any third party to, develop, create, use, sell or distribute any promotional materials or merchandise bearing any representation of the trophy or any replica thereof (including trophy lift images) or use any such representation in a manner that could lead to an association between any third party and the trophy and/or the competition.
- 10.04 The winning team is presented with 30 gold medals and the runner-up with 30 silver medals. The runners-up of each group in the final tournament each receive 30 bronze medals. Additional medals may not be produced.
- 10.05 Each team that competes in the final tournament receives a commemorative plaque.
- 10.06 Each player and official participating in the final tournament receives a commemorative diploma.
- 10.07 A special award may be presented to the top goal-scorer of the final tournament.
- 10.08 A scaled-down replica fair play trophy is awarded to the team that wins the fair play competition.

---

## Article 11 Intellectual property rights

---

- 11.01 UEFA is the exclusive owner of all intellectual property rights of the competition, including any current or future rights in all types of audio and visual material of the competition, names, logos, visual identities, brands, music, mascots, medals, plaques, commemorative items, trophies and certain key elements of the official match ball design. Any use of the aforementioned rights, any imitation and/or variation thereof and any other reference to the competition (such as by associating the name of an association with the date of a match) requires the prior written approval of UEFA and must comply with any conditions imposed by UEFA.
- 11.02 All rights to the fixture list and match schedule, as well as any data and statistics (including databases in which such data is stored) in relation to the matches of and players' participation in the competition are the sole and exclusive property of UEFA. No tickets or accreditation may be used by anyone in order to gain access to a venue for the purposes of collecting or gathering such data, and such activities are expressly prohibited. The foregoing prohibition does not apply to the participating associations, subject to any and all such data collected being used solely for the purposes of instructing their team, players and officials and expressly excluding any other exploitation or use whatsoever.

---

## II Competition System

---

### Article 12 Competition stages and seeding

---

- 12.01 Matches in all stages of the competition are played in conformity with the *IFAB Laws of the Game*. The half-time interval lasts 15 minutes.
- 12.02 The competition stages are as follows:
- a. Qualifying competition:
    - preliminary round;
    - intermediate round;
  - b. Final tournament:
    - group stage;
    - final.
- 12.03 The UEFA administration establishes coefficient rankings based on the sporting results of the last three competitions (see [Annex A](#)).
- 12.04 Five teams play the preliminary round and 32 teams participate in the intermediate round.

---

### Article 13 Match system and group formation – qualifying competition

---

- 13.01 For all matches in the qualifying competition, three points are awarded for a win, one point for a draw and none for a defeat.
- 13.02 The five teams participating in the preliminary round are drawn into two groups: Group 1 comprises teams A, B and C; Group 2 comprises teams D and E.
- 13.03 The preliminary round is played in one of the countries of the participating teams as follows:
- a. Group 1 is played in the form of a three-team mini-tournament;
  - b. Group 2 is played in the form of a knockout match over two legs.
- 13.04 In the event that less than five teams participate in the preliminary round, the round will be played in the form of a mini-tournament in one of the countries of the group. The UEFA administration will decide on further implementation details.
- 13.05 The winners of each group qualify for the intermediate round and play each other in a single-leg match to determine the winner and runner-up of the preliminary round.
- 13.06 The 30 teams that qualify directly for the intermediate round and the two teams qualified through the preliminary round are drawn into eight groups of four teams.
- 13.07 Intermediate round matches are played in the form of mini-tournaments in one of the countries in the group.
- 13.08 Each team plays each of the other teams in the group once.

**13.09** The eight group winners in the intermediate round qualify for the final tournament.

---

#### **Article 14 Equality of points – qualifying competition**

---

- 14.01** If two or more teams in the same group are equal on points on completion of a mini-tournament, the following criteria are applied to the mini-tournament in question, in the order given, to determine the rankings:
- a. higher number of points obtained in the matches played among the teams in question;
  - b. superior goal difference from the matches played among the teams in question;
  - c. higher number of goals scored in the matches played among the teams in question;
  - d. if, after having applied criteria a) to c), teams still have an equal ranking, criteria a) to c) are reapplied exclusively to the matches between the remaining teams to determine their final rankings. If this procedure does not lead to a decision, criteria e) to h) apply in the order given to the two or more teams still equal;
  - e. superior goal difference in all matches;
  - f. higher number of goals scored in all matches;
  - g. lower disciplinary points total based only on yellow and red cards received by players and team officials in the mini-tournament (red card = 3 points, yellow card = 1 point, expulsion for two yellow cards in one match = 3 points);
  - h. higher position in the coefficient rankings.
- 14.02** If two teams that have the same number of points and have scored and conceded the same number of goals play their last mini-tournament match against each other and are still equal at the end of that match, their final rankings are determined by kicks from the penalty mark (see [Paragraph 17.04](#) and [Paragraph 17.05](#)), provided that no other teams within the group have the same number of points on completion of the mini-tournament. Should more than two teams have the same number of points, the criteria listed under [Paragraph 14.01](#) apply.

---

#### **Article 15 Match system and group formation – final tournament**

---

- 15.01** Eight teams take part in the final tournament.
- 15.02** An open draw is conducted to allocate the eight teams into two groups of four.
- 15.03** The host association being A1, the two groups are formed as follows:

Group A	Group B
A1	B1
A2	B2
A3	B3
A4	B4

- 15.04 Each team plays each of the other teams in its group once, with three points awarded for a win, one for a draw and none for a defeat. The final tournament group matches are played according to the schedule below. The first-named team is considered as the home team.

- 15.05 The two group winners play the final in a single match, as follows:

## Article 16 Equality of points – final tournament

- 16.01 If two or more teams in the same group are equal on points on completion of the group matches, the following criteria are applied, in the order given, to determine the rankings:
- higher number of points obtained in the group matches played among the teams in question;
  - superior goal difference from the group matches played among the teams in question;
  - higher number of goals scored in the group matches played among the teams in question;
  - if, after having applied criteria a) to c), teams still have an equal ranking, criteria a) to c) are reapplied exclusively to the group matches between the remaining teams to determine their final rankings. If this procedure does not lead to a decision, criteria e) to h) apply in the order given to the two or more teams still equal;
  - superior goal difference in all group matches;
  - higher number of goals scored in all group matches;
  - lower disciplinary points total based only on yellow and red cards received by players and team officials in all group matches (red card = 3 points, yellow card = 1 point, expulsion for two yellow cards in one match = 3 points);
  - higher position in the coefficient rankings.
- 16.02 If two teams that have the same number of points and have scored and conceded the same number of goals play their last group match against each other and are still equal at the end of that match, their final rankings are determined by kicks from the penalty mark (see [Paragraph 17.04](#) and [Paragraph 17.05](#)), provided that no

other teams within the group have the same number of points on completion of all group matches. Should more than two teams have the same number of points, the criteria listed under [Paragraph 16.01](#) apply.

---

#### **Article 17    Knockout system, extra time and kicks from the penalty mark**

---

- 17.01** For the preliminary round knockout matches (see [Paragraph 13.03 b](#)), if the two teams involved score the same number of goals over the two legs, two 15-minute periods of extra time are played at the end of the second leg. The team which scores more goals during extra time qualifies for the match against the winner of the preliminary round group 1. If both teams score the same number of goals or no goals are scored during extra time, kicks from the penalty mark determine the winner (see [Paragraph 17.04](#) and [Paragraph 17.05](#)).
- 17.02** If there is no winner at the end of normal time in the match between the preliminary round group winners (see [Paragraph 13.05](#)) or the final, two 15-minute periods of extra time are played. If the two teams are still equal after extra time, the winner is determined by kicks from the penalty mark (see [Paragraph 17.04](#) and [Paragraph 17.05](#)).
- 17.03** If extra time is required, there is a five-minute break between the end of normal time and the start of extra time. As a rule, the players remain on the field of play during this five-minute break, at the discretion of the referee.
- 17.04** Kicks from the penalty mark are taken in accordance with the procedure laid down in the *IFAB Laws of the Game*.
- 17.05** To ensure that the procedure is strictly observed, the referee is assisted by his team, who also note down the numbers of the players on each team who have taken kicks from the penalty mark.



### III Match Scheduling

---

#### Article 18 Mini-tournament host selection

---

- 18.01 Following the draws, the teams in each group have to agree who will host the mini-tournament. If they cannot agree, the UEFA administration decides according to the following principles.
- 18.02 If one association is interested in hosting the mini-tournament, the UEFA administration designates that association as host.
- 18.03 If more than one association is interested in hosting the mini-tournament, the following criteria apply:
- a. opinion of the majority of the teams;
  - b. draw.
- 18.04 If no association expresses an interest in hosting the mini-tournament, the UEFA administration conducts a draw to determine the host.

---

#### Article 19 Match dates and fixtures

---

- 19.01 Following the draws, the teams in each group have to agree on match dates. Associations which are not represented at the meetings after the draws automatically accept the decisions taken by the other associations in their group.
- 19.02 Qualifying competition matches must be played as follows:
- a. Preliminary round before 31 July 2022;
  - b. Intermediate round before 11 December 2022.
- 19.03 If the teams of a group cannot all agree on the match dates, the host association decides in accordance with [Paragraph 19.02](#).
- 19.04 The preliminary round must be organised according to the following schedule:

Day 10:	Departure of the two group winners Departure of all referees and UEFA match officers

19.05 Intermediate round mini-tournaments must be organised according to the following schedule:

Day 1:	Arrival of the UEFA match delegate
Day 2:	Arrival of all teams Arrival of all referees and other UEFA match officers Organisational meeting
Day 3:	Matchday 1: Matches 1 v 4 and 3 v 2
Day 4:	Rest day
Day 5:	Rest day
Day 6:	Matchday 2: Matches 1 v 3 and 2 v 4
Day 7:	Rest day
Day 8:	Rest day
Day 9:	Matchday 3: Matches 2 v 1 and 4 v 3
Day 10:	Departure of all teams Departure of all referees and UEFA match officers

19.06 The match schedule for three-team mini-tournaments is as follows. Team 1 is the host association and Teams 2 and 3 the visiting associations, designated according to their coefficient (the team with the higher coefficient is Team 2, see [Annex A](#)):

Day 1:	Arrival of the UEFA match delegate

19.07 The final tournament takes place in June 2023. The exact dates will be announced by the UEFA administration.

19.08 The final tournament is played according to the following schedule:

---

## Article 20 Venues and kick-off times

---

20.01 Host associations must enter the venues for the qualifying competition in the UEFA online system, for approval by the UEFA administration, at least 60 days before the start of the preliminary round and each mini-tournament in the intermediate round.

20.02 The host association must ensure that all tournament hotels are easily accessible. Unless the visiting associations give their approval, no tournament hotel may be situated more than a three-hour bus drive from the nearest international airport. Special approval from the UEFA administration is required for tournament venues located on islands or in other places which have few international flights or which necessitate internal flights. Stadiums must be located not more than a 60-minute bus drive from all tournament hotels. In case of exceptional circumstances this time limit can be extended to a maximum of 90 minutes. Accommodation must be fixed

---

by the host association and entered in the designated UEFA online system at least 60 days before the start of the preliminary round and each mini-tournament in the intermediate round.

- 20.03 Host associations must enter the kick-off times of all qualifying competition matches in the UEFA online system, for approval by the UEFA administration, at least 30 days before the start of the preliminary round and each mini-tournament in the intermediate round.
- 20.04 For reasons of sporting fairness, matches played on the last matchday of a four-team mini-tournament and the last two matches in each final tournament group must kick off at the same time.
- 20.05 Unless the UEFA administration grants special approval, host associations are not allowed to fix kick-off times before 11.00 or after 21.00 (local time).

---

## Article 21 Team arrivals and departures

---

- 21.01 Teams must arrive at the tournament venue one day before their first match in the mini-tournament. Unless they agree otherwise with the host association, teams arriving earlier (i.e. more than one night before their first match in the mini-tournament) are responsible for the extra costs incurred as a result of their early arrival. For the final tournament, teams must arrive two days before their first match unless agreed otherwise with UEFA.
- 21.02 Visiting teams should depart the day after their last match. Teams departing any later bear the extra costs incurred as a result of their late departure.

---

## Article 22 Changes to the match schedule

---

- 22.01 If any doubt arises as to whether a match can take place as scheduled, the association concerned must immediately notify the UEFA administration. The latter decides if the match is confirmed as scheduled or if any change has to be made concerning the venue, date or kick-off time. Such decision by the UEFA administration is final.
- 22.02 The referee decides if a match cannot start or if a match which has started must be abandoned. This decision is made after consultation with the UEFA match delegate and, when possible, the UEFA administration.
- 22.03 If there are fewer than seven players on either of the teams, the match is not played or is abandoned.
- 22.04 In all cases, decisions taken on the basis of this article are without prejudice to any possible disciplinary measures.

---

## Article 23 Rescheduling of matches

---

- 23.01 If a match cannot start or cannot be played in full, the full or remaining match time is, as a rule, played on the next day, without prejudice to any possible disciplinary

---

measures. For that purpose, the host associations must conclude all the necessary agreements to ensure that the required facilities are available and can be operated.

- 23.02** If the match cannot be rescheduled the next day, the UEFA administration fixes a new date.
- 23.03** As a rule, a rescheduled match is played at the same venue. If the circumstances require a change of venue, the UEFA administration must approve the alternative venue.
- 23.04** In all cases, the UEFA administration must approve the venue and fix the new kick-off time taking account of the teams' needs wherever possible.
- 23.05** If an association is responsible for the rescheduling of all or part of a match, that association bears its own expenses, as well as any additional travel, board and lodging expenses of the other association, of the referee team and the match officers, without prejudice to any possible disciplinary measures.
- 23.06** If the match is rescheduled through no fault of either association, each party bears its own expenses related to the original fixture and the rescheduled match or remaining match time.
- 23.07** When the team of the mini-tournament host association is not one of the two teams concerned by the abandoned match, and if the remaining match time cannot be played the next day, the two teams concerned may agree to play the remaining match time in another country in order to save costs. Such a decision has to be approved by the UEFA administration.
- 23.08** In all cases, decisions taken by the UEFA administration on the basis of this article are final.
- 23.09** If the referee decides to abandon the match, the remaining match time must be played according to the following principles:
- a. The match sheet may contain any players registered for the match in accordance with [Paragraph 38.01](#), with the exception of players substituted or sent off during the abandoned match as well as players suspended for the abandoned match. The players who were in play at the time the match was abandoned may not be included on the match sheet as substitutes when the match is resumed.
  - b. Any sanctions imposed before the match was abandoned remain valid for the remainder of the match.
  - c. Single yellow cards imposed before the match was abandoned are not carried forward to any other matches before the abandoned match is completed.
  - d. Players and team officials sent off during the abandoned match cannot be replaced and the number of players in the starting line-up remains as it was when the match was abandoned.
  - e. Players and team officials who were suspended following a match played after the abandoned match in question can be included on the match sheet.
  - f. The teams can make only the number of substitutions to which they were still entitled when the match was abandoned, using their respective remaining number of stoppages in play.

- g. The match must restart on the same spot where the abandoned match action occurred (i.e. free-kick, throw-in, goal kick, corner kick, penalty, etc.). If the match was stopped during the normal flow of the game, a dropped ball on the spot where it was abandoned shall be used to restart.

---

## Article 24 Refusal to play and similar cases

---

- 24.01** If an association refuses to play or is responsible for a match (including kicks from the penalty mark) not taking place or not being played in full, the UEFA Control, Ethics and Disciplinary Body declares the match forfeited by the association concerned. Moreover, if the circumstances of the case so justify, the UEFA Control, Ethics and Disciplinary Body may impose any further disciplinary measures deemed appropriate on the association concerned, including the disqualification from the competition.
- 24.02** The UEFA Control, Ethics and Disciplinary Body can validate the result as it stood at the moment when the match was abandoned if the match result was to the detriment of the association responsible for the match being abandoned.
- 24.03** If an association is disqualified or for any reason withdraws from the competition during the qualifying competition, the results of all of its matches are declared null and void, and the points awarded forfeited.
- 24.04** If an association that has qualified for the final tournament does not compete, the UEFA administration may replace it and, if so, decide which association takes its place according to the results achieved by the associations eliminated previously.
- 24.05** An association which refuses to play or is responsible for a match not taking place or not being played in full loses all rights to payments from UEFA.
- 24.06** Upon receipt of a reasoned and well-documented request from the aggrieved association(s), the UEFA administration may set an amount of compensation due for financial loss.

---

## IV Stadium Infrastructure

---

### Article 25 Stadiums

---

- 25.01 Matches in the competition must be played in stadiums which meet the structural criteria of category 1, as defined in the *UEFA Stadium Infrastructure Regulations*.
- 

### Article 26 Pitches

---

- 26.01 The host association must ensure that the pitch is in the best possible condition for play.
- 26.02 For natural pitches, the height of the grass may not, in principle, exceed 30mm and the entire playing surface must be cut to the same height.
- 26.03 The pitch watering schedule must be communicated by the host association at the organisational meeting. The pitch must be watered evenly and not only in certain areas. As a general rule, pitch watering must finish 60 minutes before kick-off. Additional pitch watering may take place if requested by the two teams, in consultation with the UEFA match delegate and the referee, provided it takes place:
- a. between 15 and 10 minutes before kick-off; and/or
  - b. during half-time (for a maximum of 7 minutes, allowing substitute players to warm up on the field of play).
- 26.04 All goals must be set up securely and in accordance with the *IFAB Laws of the Game* and UEFA's instructions.
- 

### Article 27 Artificial turf

---

- 27.01 Matches may be played on artificial turf, in accordance with the *UEFA Stadium Infrastructure Regulations* and provided that such artificial turf is certified as FIFA Quality. The certification for each venue must be provided by the host association at least 60 days before the start of each tournament.
- 27.02 The owner of the artificial turf and the host association are fully responsible for meeting the above requirements, in particular those related to:
- a. maintenance work and ongoing improvement measures; and
  - b. safety and environmental measures as set out in the *FIFA Quality Programme for Football Turf – Handbook of Requirements* and the *FIFA Quality Programme for Football Turf – Handbook of Test Methods*.
- 27.03 The owner of the artificial turf and the host association must obtain sufficient warranties and/or guarantees related to the material and the installation from the manufacturer and the installer of the artificial turf.
- 27.04 UEFA cannot be held responsible for any damages to third parties resulting from the use of the artificial turf.

---

## Article 28 Floodlights

---

- 28.01 Matches may be played in daylight or under floodlights. If played under floodlights, the illuminance must correspond to the requirements set in the *UEFA Stadium Infrastructure Regulations*.

---

## Article 29 Clocks

---

- 29.01 Stadium clocks may be used to show the amount of time played or remaining provided they are stopped at the end of normal time in each half, i.e. after 45 and 90 minutes respectively. This stipulation also applies in the event of extra time (i.e. after 105 and 120 minutes).



---

## V Match Organisation

---

### Article 30 Match equipment

---

- 30.01** Balls must comply with the *IFAB Laws of the Game* as well as with the *UEFA Equipment Regulations*.
- 30.02** For qualifying competition matches, as well as for training sessions, balls of excellent quality must be provided by the host association. A minimum of 18 balls of the same type and quality as those used for the matches must be provided to each participating association for training.
- 30.03** For matches and training sessions during the final tournament, balls are supplied by UEFA.
- 30.04** The use of two-sided substitution boards (preferably electronic) is compulsory for all matches. For each match a minimum of two boards must be provided by the host association.

---

### Article 31 Training grounds – qualifying competition

---

- 31.01** Each team must be allocated its own training ground for the entire duration of the tournament. Exceptionally, two grounds may be shared by four teams. The teams must be able to use these grounds at any time and as often as requested. Each ground must be surfaced in the same way as the match pitches, of a similar size, in perfect condition, freshly mowed, fully marked and equipped with standard and/or mobile goals. The training grounds must be located no more than 30 minutes by bus from the corresponding teams' accommodation.
- 31.02** The dressing rooms at the training grounds must be of an adequate size for 24 persons, and the bathroom facilities must include seated toilets and meet normal standards of hygiene.
- 31.03** If the weather and state of the playing field so allow, the teams are entitled to hold a training session of up to 45 minutes the day before the match in the stadium where the match will be played. This provision applies only to each team's first match in a stadium. The UEFA match delegate, in cooperation with the host association, will take the final decision in case of any uncertainty.
- 31.04** If the teams do not train at the stadium the day before the match for whatever reason (e.g. pitch conditions), they must be permitted to visit the stadium the day before the match in order to familiarise themselves with the facilities and conditions.

---

### Article 32 Ticketing – qualifying competition

---

- 32.01** An adequate number of complimentary and purchase tickets, to be fixed by mutual agreement, must be set aside for the participating teams.

- 
- 32.02** The official UEFA representatives and at least four representatives of the participating teams must be provided with complimentary top-category seats (and associated hospitality) in the VIP sector.
- 

### **Article 33 Venue data coordinator**

---

- 33.01** The host association must ensure that the venue data coordinator (VDC) appointed by UEFA to gather live data during the match is provided with:
- a. a commentary position (or an equivalent position) with dedicated broadband internet access, which needs to be in place from the morning of the match until 90 minutes after the final whistle; and
  - b. an accreditation permitting access to the referees' dressing room.

## VI Match Procedures

---

### Article 34 Match sheet

---

- 34.01** Before matches, teams must complete the match sheet with the numbers, first names, surnames, dates of birth and, if applicable, shirt names of the 18 (final tournament: 20) players in the squad, together with the first names, surnames and functions of the officials sitting on or next to the substitutes' bench. The goalkeepers and team captains must be identified. Players must wear the shirt and short numbers as indicated on the match sheet.
- 34.02** The 11 players indicated on the match sheet as forming the starting 11 must commence the match. The other players are designated as substitutes.
- 34.03** Each team must have its match sheet validated by its competent association official and submit it at least 75 minutes before kick-off.
- 34.04** Up to five of the substitutes listed on each team's match sheet may take part in the match. Additionally, a sixth substitute listed on the match sheet may take part in knockout matches exclusively during extra time. Each team may use a maximum of three stoppages in play to make substitutions (one additional stoppage in extra-time can be used). Substitutions made before the start of the match, during half-time, between the end of normal playing time and extra time, and at half-time during extra time do not reduce the number of stoppages in play that can be used. A player who has been substituted may take no further part in the match.
- 34.05** After the validated match sheets have been submitted no changes are allowed. Before the match has kicked off, the following exceptions are possible:
- If any of the ten starting outfield players listed on the match sheet cannot start the match due to physical incapacity, he may be replaced by one of the substitutes listed on the match sheet. The replaced player is taken off the match sheet and the quota of substitute players is reduced accordingly for the match in question. During the match, five players may still be substituted.
  - If any of the substitute outfield players listed on the match sheet cannot be fielded due to physical incapacity, he may not be replaced, which means that the quota of substitute outfield players is reduced accordingly for the match in question.
  - If the starting goalkeeper listed on the match sheet cannot be fielded due to physical incapacity, he may be replaced by one of the substitutes listed on the match sheet. The replaced goalkeeper may, however, still be used as a substitute goalkeeper. If this is not possible he may be replaced by another goalkeeper included in the list of 30 players (see [Paragraph 38.01](#)).
  - If the substitute goalkeeper cannot be fielded due to physical incapacity, he may be replaced by another goalkeeper included in the list of 30 players (see [Paragraph 38.01](#)).

The association concerned must, upon request, provide the UEFA administration with the necessary medical certificates.

---

## Article 35 Match protocol

---

- 35.01** The UEFA and the UEFA Respect flags must be flown horizontally at the stadium at all matches in the competition. The flags of the participating teams should also be flown. In the case of a national amateur team, the national flag is flown and in the case of a regional amateur team, the flag of the region is flown. In addition, the flag of the host association, region or city may be flown. The UEFA and the UEFA Respect flags are available on loan from the national association.
- 35.02** The following countdown must be respected and may be adapted only to take into account the distance between the dressing rooms and the pitch.

---

### Minutes before kick-off

---

90 (latest)	Referees, UEFA match delegate and referee observer arrive at the stadium
75 (latest)	Teams arrive at the stadium
75	Deadline to submit the match sheets
45 to 15	Warm-up on the pitch
8	Stud check in the corridor
5	Teams enter the pitch and line up facing the VIP box
4 to 2	Teams shake hands, joint team photos with the referees and break for the individual team photos
1	Coin toss
0	Kick-off

---

- 35.03** Both teams must be at the stadium at least 75 minutes before kick-off.
- 35.04** The walk-on music provided by UEFA must be played from when the players emerge from the players' tunnel until they have lined up. National anthems may not be played.
- 35.05** At all matches in the competition, the players are invited to shake hands with their opponents and the referee team after the line-up ceremony as well as after the final whistle, as a gesture of fair play.

---

## Article 36 Rules governing the technical area

---

- 36.01** Eleven team officials, one of whom must be a team doctor, and seven (final tournament: nine) substitute players are allowed to sit on or next to the substitutes' bench, i.e. a total of 18 (final tournament: 20) people. The names and functions of all these people must be listed on the match sheet.

- 
- 36.02** During the match, substitutes are allowed to leave the technical area to warm up. The referee determines exactly where they may warm up (behind the first assistant referee or behind the advertising boards behind the goal) and how many substitutes are allowed to warm up simultaneously. In principle, three substitutes per team are allowed to warm up at the same time; however, if space so permits, the referee can allow additional substitutes from each team to warm up simultaneously in the determined area. The team fitness coach indicated on the match sheet may join the players warming up and is responsible for ensuring the referee's instructions are respected.
- 36.03** The use of any electronic communication equipment and/or systems is regulated by the *IFAB Laws of the Game* and the relevant instructions issued. Under no circumstances may any such systems be used by teams in connection with any kind of refereeing decision or matter.
- 36.04** Smoking is not allowed in the technical area before, during and after matches.

## VII Player Registration

---

### Article 37 Player eligibility

---

- 37.01** In order to be eligible to participate in the competition, players must meet all of the following conditions throughout the competition.
- 37.02** The players of each team must be selected from at least three different clubs that play in the division(s) determined by UEFA for their association, as indicated in the *Competition Structure* document sent to all participating associations before the start of the competition. Upon written request from an association, and after consultation with the Youth and Amateur Football Committee, the UEFA administration may make exceptions to this provision.
- 37.03** Players must never have been professional, as defined in Chapter II of the *FIFA Regulations on the Status and Transfer of Players*.
- 37.04** Players must never have played in any top national division.
- 37.05** If a player competes in the preliminary and/or intermediate round in compliance with all of the above provisions, is then transferred to a division that is outside the scope of the *Competition Structure* document but remains registered with the region he represents in the competition, he remains eligible to compete until his team's elimination, the above provisions notwithstanding.
- 37.06** Players may be of any nationality but must have been duly registered as active players with the regional association (in the case of a regional team) or the national association (in the case of a national team) they represent in the competition for at least two years without interruption on the date of their first appearance in the competition (e.g. on 1 August 2022, a player registered with the regional or national association since 1 August 2020 or before is eligible to play).
- 37.07** Players must have never played in any other senior football competition organised by UEFA, FIFA or another FIFA confederation (i.e. excluding any previous UEFA Regions' Cups and any UEFA, FIFA or other confederations' futsal competitions and age-category competitions).
- 37.08** On the date of their first appearance in the competition, players must be at least 19 and under 40 years of age; e.g.:
- on 1 August 2022, a player born on 1 August 2003 or before is eligible to play;
  - on 1 August 2022, a player born on 1 August 1982 or before is not eligible to play.
- 37.09** All players must undergo a medical examination to the extent provided for by the *UEFA Medical Regulations*.
- 37.10** The UEFA administration decides on questions of player eligibility. Challenged decisions are dealt with by the UEFA Control, Ethics and Disciplinary Body.

---

## Article 38 Player lists

---

- 38.01** Each participating team, via its national association, must provide the UEFA administration with a list of 30 players, including at least three goalkeepers as well as a head coach for each round in the competition. This list must be completed online at least 20 full days before the start of each mini-tournament and the final tournament. Once this list has been submitted no changes are allowed.
- 38.02** From the list of 30, a final list of 18 (final tournament: 20) players must be completed online by 15.00CET the day before the first match of the tournament. A signed copy together with each player's passport/identity card must be handed to the UEFA match delegate at the organisational meeting organised the day before the start of each mini-tournament and the final tournament.
- 38.03** For identification purposes, a UEFA representative makes a visual check of each player participating in the competition. As a rule, one such visual check takes place at a mealtime at the teams' accommodation before a team's first match in each mini-tournament and the final tournament.
- 38.04** The players named on the final list of 18 players (final tournament: 20) are entitled to play in the mini-tournament or final tournament. A maximum of one outfield player named on this list may be replaced upon submission to the UEFA match delegate of written medical evidence of illness or injury in one of UEFA's official languages no later than three hours before the start of the team's first match in each mini-tournament or the final tournament. The new player must be selected from the corresponding list of 30 players. The replaced player can take no further part in the mini-tournament or final tournament and no other outfield player may be replaced during the mini-tournament or final tournament. However, goalkeepers may be replaced at any time during the mini-tournament or final tournament upon submission to the UEFA match delegate of written medical evidence of illness or injury in one of UEFA's official languages. Any new goalkeeper must be selected from the corresponding list of 30 players. Replaced goalkeepers can take no further part in the mini-tournament or final tournament in which they are replaced. In cases of particular hardship and upon reasoned request, the UEFA General Secretary may grant exceptions.
- 38.05** The eight official 20-player lists for the final tournament are published by the UEFA administration.
- 38.06** The associations are responsible for ensuring that the aforementioned provisions concerning player eligibility and lists of players are observed.

# VIII Refereeing

---

## Article 39 Referee team and referee liaison officer

---

- 39.01 The *General Terms and Conditions for Referees officiating at UEFA Matches* apply to the referee teams appointed for the competition.
- 39.02 The referee team is composed of the referee, two assistant referees and the fourth official.
- 39.03 The referee team is taken care of by a referee liaison officer, who is an official representative of the host association.
- 39.04 Directly after the match, the referee validates the official match report.

---

## Article 40 Appointment and replacement of referees

---

- 40.01 The Referees Committee appoints a referee for each match. Only referees from the official FIFA list of referees are eligible.
- 40.02 Depending on the number of teams in a mini-tournament, the referees will be appointed as follows:

---

Three teams	UEFA appoints three referees from three different countries plus three assistant referees, one from each of these countries. The three assistant referees are proposed by the associations of the three referees in accordance with criteria established by the Referees Committee.
Four teams	UEFA appoints three referees from three different countries plus three assistant referees, one from each of these countries. The three assistant referees are proposed by the associations of the three referees in accordance with criteria established by the Referees Committee.  The host association appoints one substitute referee (fourth official) plus one assistant referee, in principle for the entire mini-tournament.

---

- 40.03 The Referees Committee appoints referees and assistant referees for the final tournament.
- 40.04 For the final tournament, UEFA may request the host association to appoint up to two fourth officials.
- 40.05 UEFA arranges for the referee team to arrive at the venue, in principle, the day before the start of the mini-tournament. If a member of the referee team does not arrive at the venue by the evening before the start of the mini-tournament, the UEFA administration and all teams concerned must be informed immediately. The Referees Committee, in cooperation with the UEFA administration, takes the appropriate decisions. If the Referees Committee decides to replace a member of



---

the referee team, such a decision is final, and no protests against the person or nationality of the replacement are allowed.

**40.06** If a referee or an assistant referee becomes unfit to officiate or is otherwise incapacitated before or during a match, he is replaced by another member of the referee team as follows, in accordance with the *IFAB Laws of the Game*:

- a. The referee is replaced by the fourth official.
- b. An assistant referee is replaced by the fourth official or by the reserve assistant referee if one has been appointed.

If necessary, the match will take place without a fourth official.

---

#### **Article 41 Procedure in case of severe injury to players**

---

**41.01** In the event of a suspected concussion the referee stops the game to allow the injured player to be assessed by the team doctor, in accordance with Law 5 of the *IFAB Laws of the Game*. In principle this should take no more than three minutes, unless a serious incident requires the player to be treated on the field of play or immobilised on the field for immediate transfer to hospital (e.g. spinal injury).

**41.02** Any player suffering a head injury that requires assessment for potential concussion will only be allowed to continue playing after the assessment, on specific confirmation by the team doctor to the referee of the player's fitness to do so.

---

## IX Disciplinary Law and Procedures

---

### Article 42 UEFA Disciplinary Regulations

---

- 42.01 The provisions of the *UEFA Disciplinary Regulations* apply for all disciplinary offences committed by associations, officials, members or other individuals exercising a function at a match on behalf of an association, unless the present regulations stipulate otherwise.

---

### Article 43 Yellow and red cards

---

- 43.01 As a rule, a player or a team official sent off from the field of play and/or its immediate surrounds, including the technical area, is automatically suspended for the next match in the competition. In case of serious offences, the UEFA Control, Ethics and Disciplinary Body is entitled to augment this punishment, including by extending it to other competitions.
- 43.02 In case of repeated cautions:
- a. in the qualifying competition, players and team officials are suspended for the next competition match after the second and fourth caution;
  - b. in the final tournament, players and team officials are suspended for the next competition match after the second caution.
- 43.03 Cautions that have not resulted in a suspension expire on completion of the intermediate round and are not carried forward to the final tournament.
- 43.04 Cautions that have not resulted in a suspension and pending yellow-card suspensions expire on completion of the competition.

---

### Article 44 Protests and appeals

---

- 44.01 Protests and declarations of the intention to appeal against a decision by the UEFA Control, Ethics and Disciplinary Body must be lodged in accordance with the relevant provisions of the *UEFA Disciplinary Regulations*, with the exception of the following deadlines being applicable to the final tournament:
- a. a protest must reach the UEFA Control, Ethics and Disciplinary Body within 12 hours of the end of the match in question;
  - b. a declaration of the intention to appeal against the decision by the UEFA Control, Ethics and Disciplinary Body must be lodged within 24 hours of notification of the relevant decision with grounds.

---

## X Equipment

---

### Article 45 Playing attire approval

---

- 45.01 The *UEFA Equipment Regulations* apply to all matches in the competition, unless specified otherwise in these regulations.
- 45.02 Participating associations must use playing attire that has been approved by the UEFA administration beforehand. Front and back pictures of any new playing attires to be used have to be sent to the UEFA administration for approval at least two weeks before their intended use.
- 45.03 Any playing attire alterations must be submitted to the UEFA administration for approval.

---

### Article 46 Colours

---

- 46.01 As a rule, the home team has the first choice as to which of its playing attires announced on the playing attire approval form it wears. In order to clearly distinguish between the teams on the field of play, teams may combine elements of their first-choice and second-choice playing attires. The playing attires of outfield players are selected before the goalkeeper playing attires. For the final tournament matches, the UEFA administration issues a written decision regarding the playing colours to be worn for each match.
- 46.02 If on the day of the match, in the opinion of the referee or the UEFA administration, the colours of the two teams could be confused, they will be changed. The decision taken by the UEFA administration in consultation with the referee is final.

---

### Article 47 Numbers

---

- 47.01 Players must be allocated numbers between 1 and 23. If the number 1 is used, it must be worn by a goalkeeper. No player may wear more than one number in the course of a mini-tournament or the final tournament.

---

### Article 48 Shirt sponsor

---

- 48.01 Sponsor advertising on players' shirts:
- is only allowed for teams representing regions and wearing the kits of regional associations;
  - is not allowed for teams representing nations and wearing the kits of national associations.

---

### Article 49 Badges in the final tournament

---

- 49.01 The competition badge must appear on the free zone of the right shirt sleeve.
- 49.02 The applicable UEFA campaign badge must be worn on the free zone of the left shirt sleeve.

- 
- 49.03** None of the badges may be used in any other competition, or at an earlier stage of the competition, or for any other purpose, including commercial or promotional activities, without UEFA's prior approval.

---

#### **Article 50 Equipment used in the final tournament**

---

- 50.01** Each team may be provided with special equipment which must be used at the final tournament, to the exclusion of any similar items.

---

## XI Financial Provisions

---

### Article 51 Financial rules – whole competition

---

- 51.01 The amounts paid by UEFA are gross amounts. As such they cover any and all taxes, levies and charges.

---

### Article 52 Financial rules – qualifying competition

---

- 52.01 The visiting associations cover their own international and national travel expenses to and from the mini-tournament venue.
- 52.02 The host association of the preliminary round and each intermediate round mini-tournament retains its revenue and pays all organisational costs.
- 52.03 To cover the costs of the preliminary round, the UEFA administration credits the host association with a financial contribution of €100,000.
- 52.04 To cover the costs of the intermediate round mini-tournaments, the UEFA administration credits each host association with a financial contribution based on the host country's gross national income per capita, according to the categorisation of the UEFA member associations:
- a. For four-team mini-tournaments:
    - €70,000 for a category 1 host country;
    - €80,000 for a category 2 host country;
    - €90,000 for a category 3 host country.
  - b. For three-team mini-tournaments:
    - €50,000 for a category 1 host country;
    - €60,000 for a category 2 host country;
    - €70,000 for a category 3 host country.

This amount is credited to the corresponding UEFA member association's account on completion of the intermediate round.

- 52.05 The host association pays for the board and lodging of all participating teams (for a maximum of 24 persons per delegation, i.e. 18 players and 6 team officials), and for any costs related to their transport within the host association's territory. The host association's obligations to each visiting team commence one day before the team's first match in a mini-tournament and end one day after their last match.
- 52.06 The travel costs and daily allowances of the referees appointed by the host association are borne by the host association.
- 52.07 UEFA compensates visiting associations for their teams' travel. It contributes €20,000 to each team that travels by plane, and €7,500 to each team that travels by other means. Participants are free to choose their mode of transport and must inform the UEFA administration in due time.

---

## Article 53 Financial rules – final tournament

---

- 53.01** Detailed financial information of relevance to all participating associations will be communicated at the workshop organised in conjunction with the final draw.
- 53.02** The teams that qualify for the final tournament each receive a financial contribution of €25,000 to cover the cost of the delegation's travel to the final tournament venue and one person's travel to the final tournament draw.
- 53.03** Each association taking part in the final tournament covers:
- a. the travel expenses of its delegation to and from the tournament venue;
  - b. the costs of any additional members of the delegation;
  - c. the cost of extending the duration of their stay.
- 53.04** UEFA covers the board and lodging of the players and officials of the participating associations (27 persons per delegation, one of whom must be a representative of the participating team's national association), the referees and the UEFA match officers as stipulated in the relevant appendix to the staging agreement signed by the host association and UEFA. For the teams, this coverage begins two days before their first match in the final tournament and ends the day after they have been eliminated, or the day after the end of the final tournament for the finalists.

---

## XII Exploitation of the Commercial Rights

---

### Article 54 Commercial rights – general

---

- 54.01** In the event that the host association puts in place a ticketing and media accreditation programme for its matches, the host association shall ensure that, as a minimum, the ticketing and media accreditation terms and conditions for those matches stipulate that:
- a. no person may conduct any promotional or commercial activity at the match stadium, without the prior written approval of UEFA;
  - b. tickets must not be used for any commercial purposes such as for promotion, advertising, use as a prize in a competition/sweepstake, or as part of a hospitality or travel package without the prior written approval of UEFA;
  - c. all people attending the match acknowledge that use may be made (free of charge) of their voice, image and/or likeness in still images and audio/visual transmissions relating to the match (this acknowledgement is required even if no formal ticketing programme is put in place);
  - d. no person attending the match may, without UEFA's prior written approval, collect, record, transmit and/or exploit any sound, image, data, statistics and/or description of the match for any purpose other than for private use.
- 54.02** Participating associations may not use or authorise any third party to use any of the competition trademarks or music or any graphic material or artistic forms developed in connection with the competition in programmes, promotions, publications or advertising or otherwise without the prior written consent of UEFA. In addition, participating associations may not develop, use, register, adopt or create any mark, logo or symbol which refers to the competition or which, in UEFA's reasonable opinion, is confusingly similar to, is a colourable imitation of, is a derivation of, or unfairly competes with such trademarks, materials or forms.
- 54.03** UEFA declines all responsibility and liability in the event of any conflict between any agreement entered into by an association and any arrangement entered into by UEFA relating to the exploitation of the commercial rights to the competition.

---

### Article 55 Promotional purposes

---

- 55.01** UEFA owns and has the sole right, to the exclusion of the participating associations and any other party, to exploit all the promotional rights to the competition.
- 55.02** On registering for the competition, associations must grant UEFA the right to use and authorise others to use photographic, audiovisual and visual material of their team, players and officials (including their names, relevant statistics, data and images), as well as the association name, logo, emblem, stadium image and team shirt (including references to the kit manufacturers), free of charge and worldwide for the full duration of any rights for (a) the staging and organising of the competition (and future editions of the competition); (b) non-commercial, promotional and/or editorial purposes (including the use of such material in the

multilateral production of television and media promotion and coverage of the final tournament and on/for the UEFA digital services); and/or (c) as reasonably designated by UEFA. Any such use may occur after the competition and may include references to and/or branding of third parties, including sponsors, provided that no direct association will be made by UEFA between individual players or associations and any partner. On request, the associations must supply UEFA free of charge with all appropriate material as well as with the necessary documentation required to allow UEFA to use and exploit such rights in accordance with this paragraph.

---

## Article 56 Commercial rights – qualifying competition

---

- 56.01** The host association of any match in the qualifying competition is authorised to exploit the commercial rights relating to such matches. In doing so, it must observe any instructions or guidelines issued by UEFA from time to time.
- 56.02** All agreements and arrangements pertaining to the exploitation of commercial rights in respect of the qualifying competition must be presented to the UEFA administration upon request. In addition, the commercial rights to any match in the qualifying competition may not be sold unless the sale is documented in a written agreement that provides for the payment of an appropriate fee to the host association. Any such fee forms part of the match receipts and remains with the host association.
- 56.03** UEFA owns and has the sole right, to the exclusion of the participating associations and any other party, to exploit the marketing rights to the qualifying competition generally or as a collective whole, including, by way of example, the right to nominate sponsors in relation to the qualifying competition or the competition (including the qualifying competition) as collective wholes. No participating association may participate in or allow any third party to use any rights granted by the participating association in any aggregation of marketing rights in any way that would permit a third party to create an association with the qualifying competition, the competition or the final tournament generally or as collective wholes. As a result, any grant by a participating association of marketing rights relating to the qualifying competition must be conditional upon the grantee and other third parties not exploiting the relevant rights in such a manner. By way of example, no participating association may create, or permit a third party to use rights granted by it to create, a website that is promoted as an official or dedicated website of the qualifying competition as a whole.
- 56.04** All associations participating in the qualifying competition undertake to take all legal and other measures that UEFA deems appropriate at its sole discretion to prohibit, prevent and stop any unauthorised exploitation of the commercial rights to the qualifying competition and to protect the ownership thereof.
- 56.05** For all qualifying competition matches, if televised and upon UEFA's request, associations undertake to provide UEFA, free of charge and at least 24 hours prior to the kick-off of each match, with access to the television frequency information for receiving the broadcast signal at a location of UEFA's choice. These broadcasts can be recorded by UEFA and a copy of the recording may be purchased at cost price by



the associations participating in the respective match. If the signal is unavailable for whatever reason, associations undertake to provide UEFA free of charge, in HDCAM or, if not available, in Digibeta (or another broadcast standard to be confirmed with UEFA in advance), with a recording of the entire match, to be sent to a destination of UEFA's choice for receipt within seven days of the match. The associations must ensure that any person owning rights to the above materials grants UEFA the right to use and exploit and authorise others to use and exploit, by any and all means and in any and all media whether now known or invented in the future, throughout the world, for the full duration of such rights, up to 15 minutes of audio and/or visual material from each match, free of charge and without payment of any associated clearance costs. Associations acknowledge that such use may be aimed in particular at directly or indirectly promoting the competition, including with programmes produced by or on behalf of UEFA.

---

## Article 57 Commercial rights – final tournament

---

- 57.01** UEFA is the exclusive owner of all commercial rights in relation to the final tournament. UEFA expressly reserves all such commercial rights and is exclusively entitled to exploit, retain and distribute all revenues derived from the exploitation of such commercial rights.
- 57.02** Each participating association must provide all necessary assistance and cooperation to UEFA in taking any and all legal and other measures that UEFA, at its sole discretion, deems appropriate to prohibit, prevent and stop any unauthorised exploitation of the commercial rights to the final tournament and to ensure that all the commercial rights remain owned and exercised solely and exclusively by UEFA without restriction. In this regard, no association may use or exploit, directly or indirectly, any commercial rights to the final tournament without the express prior written agreement of UEFA and subject to such conditions as UEFA may require. Each association must ensure that its players, coaches, officials and other employees as well as its partners, commercial or otherwise, do not use or otherwise exploit directly or indirectly any commercial rights to the final tournament without UEFA's express prior agreement, which may be granted or withheld at its sole discretion.
- 57.03** Unless otherwise approved by UEFA in writing, a participating association may not display third-party commercial identification or branding in any stadium chosen for the final tournament.

---

## **XIII Media Matters**

---

### **Article 58 Accreditations and access rights**

---

- 58.01** For the qualifying competition, the host association is responsible for organising a media accreditation system (accreditation cards, bibs, etc.) and for delivering the relevant accreditations to the following media representatives:
- press;
  - photographers;
  - audiovisual rights holders;
  - audiovisual non-rights holders.
- 58.02** No media representatives are allowed to go on to the field of play before, during or after the match, with the exception of the host broadcaster camera crew covering the team line-ups at the start of the match and up to two host broadcaster camera crews filming the teams after the end of the match. The same applies to the tunnel and dressing-room area, with the exception of flash interview positions and a camera of the host broadcaster filming the following activities:
- a. team arrivals (as far as to the dressing-room area);
  - b. players in the tunnel prior to entering the field (before the match);
  - c. players returning to the pitch at the start of the second half.
- 58.03** A limited number of photographers, cameramen and production staff of the audiovisual rights holders – all equipped with the appropriate pitch-access accreditation – are allowed in the area between the boundaries of the field of play and the spectators.

---

### **Article 59 Press**

---

- 59.01** Press applies to media that report in writing only, for whatever platform (e.g. newspaper, website, mobile portal). They have access to the post-match press conference and mixed zone.

---

### **Article 60 Photographers**

---

- 60.01** Photographers may work in the areas behind the advertising boards behind the goals, as well as up to the 16 meter line at the opposite touchline. They may only change ends at half-time. Photographers may not work from the tribunes or any other area unless given permission to do so by the venue media manager. They may photograph all elements of the match, including the warm-up of the teams, the line-up, handshake procedure and coin toss, the game itself, and any post-match ceremonies.

---

### **Article 61 Media access to training sessions**

---

- 61.01** Teams must make their last training session before each match open to the media for at least 15 minutes if requested. In addition and upon request, the head coach

and at least one key player from each team should be available to the media on the day before each game.

---

## Article 62 Interviews

---

- 62.01** Pre-match, half-time and post-match interviews with each team may take place at the stadium as follows. Timings and locations must be agreed in advance by UEFA and each team.
- a. On request, the head coach or a player on the match sheet must be made available for a short interview before the match, related exclusively to the match in question, with the host broadcaster and the main audiovisual rights holder of the team's country.
  - b. Additional pre-match interviews may be conducted with the head coach and players, subject to their agreement.
  - c. Half-time interviews may be conducted with head coaches, assistant coaches or players, subject to their agreement.
  - d. The head coach and at least two key players must be available for a minimum of one post-match super-flash interview with the main audiovisual rights holders of the team's country, in a designated area next to or on the pitch.
  - e. If requested, flash interviews are obligatory and take place after the match. Each team must make the head coach and three players available to the audiovisual rights holders. Teams must ensure that the head coach and players are available for such interviews within 15 minutes of the end of the match.

---

## Article 63 Press conferences and mixed zone

---

- 63.01** If applicable, the post-match press conference must start no later than 20 minutes after the end of the match. Both teams are obliged to make at least their head coach available for this purpose.
- 63.02** After the match, a mixed zone must be set up between the teams' dressing rooms and the team transport area. This area offers reporters additional opportunities to conduct interviews and is accessible only to coaches, players and media representatives. It should feature sufficient space to accommodate at least ten media representatives, with barriers between the players and the media.
- 63.03** All players from both teams who have participated in the match, either in the starting line-up or as substitutes, are obliged to pass through the entire mixed zone in order to conduct interviews with the media.

---

## XIV Closing Provisions

---

### Article 64 Implementing provisions

---

- 64.01 The UEFA administration is entrusted with the operational management of the competition and is therefore entitled to take the decisions and adopt the detailed provisions and guidelines necessary for implementing these regulations.

---

### Article 65 Unforeseen circumstances

---

- 65.01 Any matters not provided for in these regulations, such as cases of force majeure, are settled by the UEFA General Secretary, whose decisions are final.

---

### Article 66 Non-compliance

---

- 66.01 Any breach of these regulations may be penalised by UEFA in accordance with the *UEFA Disciplinary Regulations*.

---

### Article 67 Court of Arbitration for Sport (CAS)

---

- 67.01 In case of litigation resulting from or in relation to these regulations, the provisions regarding the Court of Arbitration for Sport (CAS) laid down in the *UEFA Statutes* apply.

---

### Article 68 Annexes

---

- 68.01 All annexes form an integral part of these regulations.

---

### Article 69 Authoritative version

---

- 69.01 If there is any discrepancy in the interpretation of the English, French or German versions of these regulations, the English version prevails.

---

## Article 70 Adoption and entry into force

---

70.01 These regulations were adopted by the UEFA Executive Committee on 10 May 2022, with amendments approved on 16 August 2022 and on 20 September 2022, and come into force immediately.

## Annex A Coefficient Ranking System

### A.1 System overview

UEFA calculates a coefficient for each association that takes part in the competition. These coefficients are used to rank the associations to determine the round in which each team enters the competition and to seed the teams for the draws.

### A.2 Reference period for the calculation of the coefficients

The coefficient rankings are established for the preliminary and intermediate round draws on the basis of the associations' results in the three most recent completed seasons at the time of the draws. For the 2022/23 competition, the coefficient rankings are therefore based on the associations' results in the seasons 2014/15, 2016/17 and 2018/19.

### A.3 Match points

Points are awarded for each match played in the qualifying competition. Match points are awarded in accordance with the final scores as ratified by UEFA. Final tournament matches and penalty shoot-outs are not taken into consideration.

Points are awarded as follows:

- 3 points for a win;
- 1 point for a draw;
- 0 points for a defeat.

### A.4 Bonus points

In addition to the match points, the following bonus points are awarded for each season:

- 3 points for automatic qualification for the intermediate round;
- 3 points for qualification from the preliminary round to the intermediate round;
- 3 points for qualification from the intermediate round to the final tournament;
- 3 points for winning the final tournament;
- 2 points for being runner-up in the final tournament.

### A.5 Coefficient calculation

The coefficient of an association is calculated by adding up the points obtained (including bonus points) in a given season then dividing the total by the number of qualifying competition matches played. The three annual coefficients are then added together to produce the overall coefficient.

If two or more associations have an equal coefficient, the following criteria are applied, in the order given, to determine their final rankings:

- a. higher number of matches;
- b. higher coefficient from the most recent season;

- 
- c. higher coefficient from the next two most recent seasons;
  - d. superior goal difference from the most recent season;
  - e. superior goal difference from the next two most recent seasons.

#### A.6 Final decisions

The UEFA administration takes final decisions on any matters not provided for in this annex.

---

## Annex B Mini-Tournament Requirements

### B.1 Introduction

This annex sets out the minimum requirements for hosting a mini-tournament in the UEFA Regions' Cup. For the sake of simplicity, "host" refers to the host association.

### B.2 Local organising structure

The host is responsible for setting up a local organising structure (LOS) composed of at least:

- a. 1 tournament director, who should not have a leading role with his own team;
- b. 1 transport manager;
- c. 1 referee liaison officer (RLO) to be appointed by the association, preferably an active or former referee, who must speak fluent English, be familiar with the region where the tournament is taking place and hold a valid driving licence;
- d. 1 sports facilities and safety/security officer, who is responsible for informing the competent local authorities about the mini-tournament, implementing the orders of the local authorities and UEFA regarding safety and security (no sale of alcohol, confiscation of dangerous objects at the venue, anti-racism measures, prevention of pitch invasions, securing the technical area, etc.) and ensuring that all necessary measures are implemented so that the teams, officials, spectators, etc. are provided with a safe, comfortable and friendly environment;
- e. 1 medical officer, who is responsible for ensuring that UEFA medical requirements are met in accordance with the *UEFA Medical Regulations*;
- f. 1 team liaison officer for each visiting team, who is service-minded, available 24 hours a day, has a good command of English, a good knowledge of football, and a good knowledge of the region where the tournament is taking place as well as, if possible, knowledge of the language of the team to which they have been assigned:
  - to ensure that the team is satisfied with the facilities and services provided;
  - to assist the team in all matters from their arrival in until their departure from the host country;
  - to act as the link (contact person) between the team and the LOS and any UEFA representatives;
  - if applicable, to attend daily meetings with the LOS to discuss all practical matters;
  - to accompany the team to all events, if requested, including meetings, training sessions, matches and excursions;
  - to ensure that any material or services promised to the team by the LOS are delivered;
  - to attend any official meetings;
  - to act as an interpreter;
  - to provide useful information on the lifestyle and traditions of the country and region where the tournament is taking place.



---

g. 1 press officer.

The host must ensure that the members of the LOS are duly authorised to fulfil their various tasks.

### **B.3 UEFA match officers**

As a rule, UEFA appoints for each mini-tournament one match delegate and two referee observers from countries other than those of the referees and teams.

The UEFA match officers must be able to communicate by email with the UEFA administration immediately after matches, from either the stadium or the hotel. The host is responsible for providing the UEFA match officers with the necessary means of communication.

The UEFA match officers are instructed not to pay any hotel bills except to settle extras (mini-bar, additional meals, phone calls, etc.).

The accommodation costs (board and lodging) of the UEFA match officers must be borne by the host, who is reimbursed by means of the standard UEFA contribution.

### **B.4 Preliminary inspections**

UEFA may organise a preliminary inspection of the proposed tournament facilities (accommodation, stadiums, training grounds, etc.). Upon receipt of the corresponding report, UEFA is entitled to request that other facilities be proposed.

### **B.5 Tournament organisational meeting**

A tournament organisational meeting must be held, preferably the day before the start of the tournament. The time of this meeting must be determined according to the arrival of the teams and UEFA match officers. If this meeting cannot take place the day before the start of the tournament, it should be organised on the morning of the first matchday.

The meeting is chaired by the UEFA match delegate and held in English. It must be attended by the following persons:

- a. UEFA
  - Match delegate
  - Referee observer
- b. Teams
  - Head of delegation
  - Team liaison officer (if possible)
- c. LOS
  - Tournament director
  - Sport facilities and safety/security officer
  - Transport officer
  - Medical officer
  - Referee liaison officer

- Press officer.

The aim of this meeting is to provide the teams and all the other parties with a role in the tournament with the following information:

- a. Tournament programme
- b. Rules and guidelines regarding the hotel(s)
- c. Match arrangements
- d. Transport system
- e. Referee appointments
- f. Instructions on the use of training grounds (deadline to respect in case of changes to training schedule and cost of rental if cancelled at the last minute)

In addition, at the end of the meeting, the UEFA match officers, in cooperation with the heads of delegation, determine the team colours for all matches and check, together with the LOS, the colours to be used by the ball kids.

Furthermore, the match delegate, in cooperation with the heads of delegation, arranges a schedule for the players' identity checks. If the teams are in different hotels, the match delegate can ask the referee observer – but not the referees – to help him.

For these purposes, each head of delegation is requested to bring with him to the meeting the final 18-player list, the players' passports and the full first and second-choice kits for the outfield players (shirt, shorts and socks), as well as the full goalkeeper kits.

A room with a capacity for a minimum of 30 people must be reserved for this tournament organisational meeting.

If deemed necessary, an additional meeting between the tournament director, the heads of delegation and the match delegate may be organised each morning in order to review the previous day, discuss the programme for the current and next day and raise any complaints or suggestions.

## **B.6 Accommodation requirements**

The delegations must be accommodated either in sports schools or medium-standard hotels (standard three-star), both being referred to as hotels in these regulations. If possible, each team should be accommodated on a different floor or wing. The host must:

- a. ensure that the teams can prepare for their matches in a comfortable, quiet and undisturbed environment;
- b. at the organisational meeting, provide the delegations with clear information on safety regulations and procedure applicable in case of an emergency, rules regarding telephones, pay-TV, internet, mini-bars and other extras, as well as the code of conduct in the hotel;
- c. prepare a room occupancy plan and distribute it to the UEFA representatives only;

d. ensure that all rooms:

- have bathroom and toilet facilities which meet standard hygiene requirements;
- have adequate wardrobe space;
- are equipped with heating and/or air-conditioning;
- are cleaned daily.

#### **B.6.1 Rooms for the delegations**

The host must provide and pay for the following rooms for each delegation (maximum of 24 persons per delegation):

- a. Twin rooms for the players (nine rooms for 18 players); two single beds separated from each other must be provided in these rooms; one large bed for two players is not acceptable.
- b. Single rooms for the 6 team officials (6 rooms) in the same hotel as their team.
- c. A storage room for each team (ideally on the team's floor/wing)
- d. One room per team for medical treatment and massages which should be located near to the physiotherapist's/masseur's room and contain a massage table.

A suite could be provided for use as a storage and medical room with massage table.

Additional delegation members may be accommodated at the same place or nearby – at the expense of the visiting association.

#### **B.6.2 Rooms for the referees and UEFA match officers**

Single rooms must be provided for the referees and the UEFA match officers.

The refereeing group (eight referees, UEFA referee observer(s) and, if applicable, referee liaison officer) must be accommodated at a different hotel from the teams. In exceptional circumstances, and after approval by the UEFA administration, they can be accommodated in the mini-tournament headquarters. However, the refereeing group should not be accommodated with one single team.

The UEFA match delegate must be accommodated at the mini-tournament headquarters or in one of the hotels used for the teams.

#### **B.6.3 Meeting rooms**

The host must cover the costs for the following meeting rooms equipped with a flip chart and TV/DVD set or projector, according to the team's requests:

- a. Each team should be provided with a meeting room for a minimum of 25 people, to be at its disposal for the entire duration of the tournament. If this is not possible, two teams can be asked to share one meeting room. A meeting schedule should be established with the teams before the organisational meeting.
- b. One meeting room must be booked for the referees (at the referees' hotel).

---

#### **B.6.4 Dining room**

A spacious dining room split into different areas – one for the teams, one area for the UEFA match delegate and LOS and, if in the same hotel, one for the referees – must be provided.

### **B.7 Food requirements**

#### **B.7.1 Meals**

Meals must be provided according to the following rules:

- a. Three meals a day must be served to the teams and the UEFA representatives in accordance with their match and training schedules. Menus should respect sports nutrition guidelines as well as taking the national eating habits of the participating teams into account.
- b. A detailed menu plan must be submitted to the participating teams one month before the start of the mini-tournament. Should a team have any special dietary requests, these must be submitted to the host at least two weeks before the start of the mini-tournament. Any cost difference between the proposed and requested menus must be borne by the requesting team.
- c. The hotels should be flexible when it comes to catering for special requests and the teams should be able to bring their own cook, food and drink. The hotels must also be flexible about mealtimes in order to adapt to the kick-off times of matches and the teams' return travel to the hotel.
- d. A good variety of food in sufficient quantities must be provided. All meals should be served buffet style and the food must be kept at an appropriate temperature all the time.

#### **B.7.2 Snacks, light meals**

As a rule, snacks or light meals between ordinary meals must be made available to the teams upon request and paid for by them. However, if such a meal replaces an ordinary meal, the host must cover the costs. If it consists of an additional meal, the requesting team must pay for it.

#### **B.7.3 Drinks**

A sufficient supply of still mineral water, coffee and tea must be made available for the participants at the three meals covered by the mini-tournament budget, while milk (hot and cold), fruit juice and chocolate drinks or powder must also be available at breakfast time. In addition, a minimum of 70 litres of still mineral water must be provided per day for each team to cover their needs for their training sessions, matches and other use such as water in their rooms. Still mineral water and energy drinks should also be provided to the refereeing group. All other drinks must be paid for by the teams or individuals concerned.

---

## B.8 Laundry of the match playing attire

The host must pay for a 24-hour laundry service (hotel service or other) for the playing attire of the participating teams and referees (playing attire which has been worn for matches, i.e. shirts, shorts and socks, but not tracksuits, undershirts and undershorts).

## B.9 Tournament office

A centrally located and easily accessible tournament office must be set up at the hotel or one of the hotels where the teams are staying. It should be equipped with an internet connection or Wi-Fi, a photocopier and a small printer – unless these last two services can be provided by the hotel at the host's expense. This room serves as the mini-tournament headquarters, where:

- a. the UEFA match delegate and, if accommodated in the same hotel, the refereeing group can carry out administrative work;
- b. information can be obtained on the mini-tournament.

## B.10 Transport

The host is responsible for satisfying the following transport requirements:

- a. The teams, referees and UEFA match officers must be welcomed upon their arrival in the host country and transported to the hotel. They must also be provided with transport from their accommodation to their point of departure at the end of their stay.
- b. Each team must be provided with a modern 50-seater bus (with air-conditioning and dedicated driver) for the entire duration of the tournament to cover all the team's reasonable requests, including local excursions. The host must provide the visiting teams with the transport concept/rules at the organisational meeting.
- c. Two people carriers (minibuses with nine seats) with drivers must be provided to transport the referees to and from matches.
- d. Anti-doping controls (three additional vehicles per match, i.e. one per team to transport the players and team doctor back to the hotel and one for the doping control officer).
- e. The host is also requested to organise transport for official members of delegations who would like to see matches involving opponents.

---

## Annex C Special rules applicable to the intermediate round and the final tournament due to COVID-19

NB: If there is any discrepancy between the rules of this Annex and the provisions to be found in the present regulations or in any other sets of rules adopted by the UEFA Executive Committee, the rules below prevail.

### C.1 Testing and player eligibility

- C.1.1 Should a group of players of a team be placed into mandatory quarantine or self-isolation following positive COVID-19 tests and in line with the measures set out in the UEFA Return to Play Protocol (and/or following a decision of a competent national/local authority), the match(es) will take place as scheduled if at least 13 players registered on the players list (including at least one goalkeeper) are available. If less than 13 players registered on the players list or no registered goalkeeper are available, UEFA may allow a rescheduling of the match(es) (i.e. subject to viable rescheduling options being available) to allow a sufficient number of players (at least 13 players including at least one goalkeeper) to participate in the match(es). In this case, the team may field players who have not been registered with UEFA within the deadlines stipulated in the present regulations, provided that these players (i) are eligible to play in accordance with [Article 37](#) of the competition regulations and (ii) that they fulfil the requirements of the UEFA Return to Play Protocol. Any additional player, included in the list of 30 players, called up to meet at least the minimum of 13 players requires that an equivalent number of quarantined players are definitively withdrawn from the 18 players list (20 players list for the final tournament). If it is not possible to reschedule the match(es) within the final deadline set out in [Annex C.2.1](#), the team that cannot play the match(es) will be held responsible for the match(es) not taking place and the match(es) will be declared by the UEFA Control, Ethics and Disciplinary Body to be forfeited by the team, which will be considered to have lost them by 3-0. Moreover, the UEFA Control, Ethics and Disciplinary Body may take further disciplinary measures if the circumstances so justify.
- C.1.2 If any member of the appointed referee team for a match tests positive for COVID-19, UEFA may exceptionally appoint replacement match officials who (i) may be of the same nationality as one of the teams, and/or (ii) may not be on the FIFA list.

### C.2 Completion of the intermediate round and the final tournament

- C.2.1 In any case, the UEFA administration may reschedule matches and assign the rescheduled matches to an alternative venue if this ensures a match is played and allows the intermediate round and/or the final tournament to be completed accordingly. This should not jeopardise the schedule of any forthcoming phase in the competition. Such decisions of the UEFA administration are final. The

rescheduled matches of the intermediate round must be played by 11 December 2022 at the latest.

- C.2.2 If, for any reason, the intermediate round cannot be staged or completed in accordance with this Annex, the UEFA Executive Committee will decide on the principles for determining the teams qualified for the next round.

### C.3 Closing provision

- C.3.1 Any unforeseen circumstances related to this Annex will be dealt with in accordance with [Paragraph 65.01](#) of the present regulations.
