- Acts of damage, Art. 16(2)(f) DR
 - > Fine: €25,000
 - > Ban from selling tickets for away matches during its next one (1) UEFA competition match, suspended for a probationary period of two (2) years.
 - Contact home club for the settlements of the damages

Paris Saint-Germain vs. AC Milan (3:0); 25 October 2023

Incidents and decision:

- Lighting of fireworks, Art. 16(2)(c) DR
 - > Fine: €75,000
 - Partial stadium closure during its next one (1) UEFA club competition match as host club, suspended for a probationary period of two (2) years.
- Blocking of public passageways, Art. 38 SSR
 - ➤ Fine: €18,000
- Invasion of the field of play, Art. 16(2)(a) DR
 - > Fine: €5,000

AC Milan

- Crowd disturbances, Art. 16(2)(h) DR
 - > Fine: €20,000
- Lighting of fireworks, Art. 16(2)(c) DR
 - ➤ Fine: €3,000

 - > Suspension for one (1) UEFA club competition match

Olympiacos FC vs. West Ham United FC (2:1); 26 October 2023

Olympiacos FC

- Improper conduct of the team (5 players or more), Art. 15(4) DR
 - > Fine: €7,000
- Invasion of the field of play by its supporters, Art. 16(2)(a) DR
 - > Fine: €4,000
- Racist behaviour, Art. 14(2) DR
 - > Fine: €10,000
 - > Partial stadium closure during its next one (1) UEFA club competition match as host club, suspended for a probationary period of two (2) years.

KRC Genk vs. Ferencvárosi TC (0:0); 26 October 2023

KRC Genk

Incidents and decision:

- Rough play (Mr. Toluwalase Emmanuel Arokodare), Art. 15(1)(a)(ii) DR
 - Suspensions for one (1) UEFA club competition match
- Lighting of fireworks, Art. 16(2)(c) DR
 - > Fine: €20,000
 - Partial stadium closure during its next one (1) UEFA club competition match as host club, suspended for a probationary period of two (2) years.

FC Lugano vs. Club Brugge (1:3); 26 October 2023

Club Brugge

Incidents and decision:

- Lighting of fireworks, Art. 16(2)(c) DR
 - ➤ Fine: €32,500
- Throwing of objects, Art. 16(2)(b) DR
 - > Fine: €18,000

HŠK Zrinjski vs. Legia Warszawa (1:2); 26 October 2023

HŠK Zrinjski

- Racist and/or discriminatory behaviour, Art. 14(2) DR
- Throwing of objects, Art. 16(2)(b) DR
- Lighting of fireworks, Art. 16(2)(c) DR
 - Match behind closed doors for its next one (1) UEFA club competition match, suspended for a probationary period of two (2) years.
- Failure to adequately screen and/or search spectators, Art. 33.01 SSR
 - > Fine: €10,000

UEFA European Qualifying Competition for the 2024 FIFA Futsal World Cup

Georgia vs. Finland (5:2); 07 October 2023 Finland vs. **Georgia** (3:3); 11 October 2023

Georgia

Incident and decision:

- Art. 38.01 Regulations of the UEFA European Qualifying Competition for the 2024 FIFA Futsal World Cup
 - Declare the UEFA European Qualifying Competition matches for the 2024 FIFA Futsal World Cup Georgia vs. Finland played on 7 October 2023 and also Finland vs. Georgia played on 11 October 2023, as forfeited by Georgia, who is therefore deemed to have lost the respective matches 0-5
 - > Fine: €5,000

Romania vs. Netherlands (2:1); 06 October 2023 Netherlands vs. Romania (1:1); 10 October 2023

Romania

Incident and decision:

- Art. 38.01 Regulations of the UEFA European Qualifying Competition for the 2024 FIFA Futsal World Cup
 - ➤ Declare the UEFA European Qualifying Competition matches for the 2024 FIFA Futsal World Cup Romania vs. Netherlands played on 6 October 2023 and also Netherlands vs. Romania played on 10 October 2023, as forfeited by Romania, who is therefore deemed to have lost the respective matches 0-5

Armenia vs. Portugal (5:6); 06 October 2023 Portugal vs. Armenia (7:1); 11 October 2023

Armenia

- Art. 38.01 Regulations of the UEFA European Qualifying Competition for the 2024 FIFA Futsal World Cup.
 - ➤ Declare the UEFA European Qualifying Competition matches for the 2024 FIFA Futsal World Cup Armenia vs. Portugal played on 6 October 2023 and also Portugal vs. Armenia played on 11 October 2023, as forfeited by Armenia, who is therefore deemed to have lost the matches respectively 0-5 and 7-1.
 - ➤ Fine: €5,000

Incidents and decision:

• Throwing of objects, Art. 16(2)(b) DR

➤ Fine: €80,000

• Lighting of fireworks, Art. 16(2)(c) DR

➤ Fine: €5,500

• Blocking of public passageways, Art. 38 SSR

> Fine: €18,000

Greece vs. Netherlands (0:1); 16 October 2023

Greece

Incidents and decision:

- Unsporting conduct (Mr. Gustavo Augusto Poyet Dominguez), Art. 15(1)(a)(v) DR
 - > Suspensions from carrying out a function for one (1) UEFA representative team match
- Use of laser pointer, Art. 16(2)(d) DR

➤ Fine: €20,000

• Throwing of objects, Art. 16(2)(b) DR

➤ Fine: €14,375
