 - Declare the UEFA European Under-17 Championship 2024 qualifying round matches Wales vs. Israel scheduled on 15 November 2023, Israel vs. Gibraltar scheduled on 18 November 2023 and Israel vs Belgium scheduled on 21 November 2023, as forfeited by Israel, who is therefore deemed to have lost the respective matches 0-3
