**2022/23 UEFA Women's Champions League –
Solidarity payment scheme supporting women's club development**

Dear Sir or Madam,

We are pleased to inform you that the solidarity payments from the 2022/2023 UEFA Women's Champions League are now available and will be paid to UEFA member associations during the 2023/2024 season for distribution to their clubs for development purposes.

The money earmarked for this solidarity scheme represents 23% (€5.6 million) of the total estimated amount of €24 million available for distribution in the 2022/23 season.

The scheme aims to encourage simultaneous growth and increase standards, while taking account of the different local environments and varying stages of development in clubs and national associations throughout Europe. It is a key component of the UEFA Women's Champions League financial distribution model, ensuring that money invested in or generated by the UEFA Women's Champions League benefits all European top-division women's clubs.

Please note the following important information

1. Distribution criteria

Under the scheme, each association that entered at least one club in the 2022/23 UEFA Women's Champions League will receive an amount to distribute equally among all the clubs in its top-division domestic women's championship that did not participate in that season's Women's Champions League (see enclosure 1). The applicable domestic season is the same as that in which the solidarity payments are generated, i.e. the 2022/23 season for summer-to-spring leagues or the 2022 season for spring-to-autumn leagues.

The solidarity share that non-participating clubs are entitled to receive is directly correlated with the sporting performance of the participating clubs from their respective countries. If an association had more than one club in 2022/23 UEFA Women's Champions League the club that progressed the furthest (i.e. the best performing) was used to calculate the amount.

2. Use of funds

The solidarity payments must be used by clubs to fulfil or improve one or more of the existing and measurable sporting, infrastructure, administrative and personnel criteria as laid down in the *UEFA Club Licensing Regulations for the UEFA Women's Champions League (chapter 3, Club Licensing Criteria)*. A summary of the eligible uses of these funds is attached (enclosure 2).

As the payments are for development purposes, they may not be used for the club's fixed and ordinary costs. Clubs with men's and women's sections may only use the funding for the women's section.

3. Application process

The national associations are responsible for managing applications and communicating with clubs.

The following must be emailed to NAServices@uefa.ch, for the attention of Marios Georgiou, by 29 February 2024:

1. A payment request indicating the amount in euros, together with the name, position and signature of the competent person at the national association.
2. The completed application form (enclosure 3) with the names of the recipient clubs, criteria to be improved, specific areas to be addressed, and details of precisely how each club will invest the funding. The clubs listed must match those on the 'UEFA Women's Champions League 2022/23 Solidarity Payment Scheme – domestic competitions information' form submitted to UEFA by the national associations.

On receipt of the documentation, UEFA will evaluate the applications prior to releasing the payments.

4. Payment procedure

Once the national association has received the amount due from UEFA, it must immediately distribute it in full to the eligible clubs, without retaining or earmarking any of that money for other purposes, and properly acknowledge the source of the funding. It is suggested that the following wording accompany payments to clubs:

"This payment is made under the UEFA Women's Champions League 2022/23 Solidarity Payments Scheme. Its purpose is to help clubs increase standards in line with the UEFA Women's Champions League licensing criteria and prepare clubs for future participation in the competition. The scheme provides a framework for clubs to support their own unique development needs, and is aligned with the strategic aims of UEFA, its member associations, and their clubs, to professionalise women's football. This payment is therefore to be used solely for the purpose stated by the club in accordance with the Solidarity Payments Scheme."

It should be noted that UEFA solidarity payments to clubs are separate from and must not replace any existing funding streams from the national associations to their clubs.

5. Records

National associations must keep a record of all clubs that receive funding. Records must include the amount received, and any other relevant information set out in this circular letter. Please note that, national associations will be requested to provide the UEFA administration with evidence that this money has been forwarded to the clubs concerned and has been used by them for the purpose stated on the application form.

Please also note that we may wish to quote the success of this solidarity mechanism in public documents, e.g. by listing the beneficiary clubs in UEFA publications, using information you have sent us.
