- Late kick-off (Mr. Goncalo Feio), Art. 11(2)(h) DR
  - Suspension: one (1) UEFA club competition match. Said suspension is subject to a probationary period of one (1) year.
- Unsporting conduct (Mr. Maciej Treutz-Kuszyński), Art. 15(1)(a)(v) DR
  - Suspension: one (1) UEFA club competition match

  - Warning
- Late kick-off (Mr. Vincenzo Montella), Art. 11(2)(h) DR
  - Warning

### [Romania vs. Lithuania \(3:1\); 9 September 2024](#)

#### **Romania**

Incidents and sanction:

- Transmitting a message not fit for a sports event, Art. 16(2)(e) DR
  - Fine: €22,500
- Racist and/or discriminatory behaviour, Art. 14 DR
  - Fine: €30,000
  - Partial stadium closure during the next one (1) UEFA representative team competition match

## Out of competition

### [Bartosz Frankowski](#)

Incident and sanction:

- Violation of the general principles of conduct Art. 11(1) DR in conjunction with Art. 11(2)(b) (basic rules of decent conduct) and Art. 11(2)(d) DR (bringing the sport of football, and UEFA in particular, into disrepute)
  - Suspension: ban from carrying out any refereeing function at UEFA competitions until 30 June 2025

Incident and sanction:

- Violation of the general principles of conduct Art. 11(1) DR in conjunction with Art. 11(2)(b) (basic rules of decent conduct) and Art. 11(2)(d) DR (bringing the sport of football, and UEFA in particular, into disrepute)
  - Suspension: ban from carrying out any refereeing function at UEFA competitions until 30 June 2025
