- Racist and/or discriminatory behaviour, Art. 14(2) DR
 - Fine: €30,000
 - Ban from selling tickets to its away supporters for the next one (1) UEFA club competition match. Said ban from selling tickets to its away supporters is subject to a probationary period of one (1) year
- Throwing of objects, Art. 16(2)(b) DR
 - Fine: €10,000

SL Benfica

Incidents and sanction:

- Lighting of fireworks, Art. 16(2)(c) DR
- Acts of damage caused to the stadium and/or its installations, Art. 16(2)(f) DR
 - Fine: €10,000
 - Ban from selling tickets to its away supporters for the next one (1) UEFA club competition match. Said ban from selling tickets to its away supporters is subject to a probationary period of two (2) years
 - Contact Paris FC for the settlement of the damages caused by its supporters

Incident and sanction:

- Serious rough play (Mr. James Norris), Art. 15(1)(d) DR
 - Suspension: two (2) UEFA club competition matches
