  - Fine: €30,000
  - Ban from selling tickets to its away supporter for one (1) additional UEFA club competition match.
- Acts of damage caused to the stadium and/or its installations, Art. 16(2)(f) DR
  - Fine: €8,000
  - Contact FC Barcelona for the settlement of the damages caused by its supporters

**FC Bayern München**

Incidents and sanction:

- Blocking of public passageways, Art. 38 UEFA Safety and Security Regulations
  - Fine: €16,000
- Lighting of fireworks, Art. 16(2)(c) DR
  - Order the enforcement of the suspended disciplinary measure imposed by the Control, Ethics and Disciplinary Body in its decision of 13 March 2025, i.e. to order the partial stadium closure during the next one (1) UEFA club competition match in which it will play as host club,
  - Fine: €30,000
  - Partial stadium closure for one (1) additional UEFA club competition match it will play as host club. Said partial stadium closure is suspended for a probationary period of two (2) years

**Sporting Clube de Portugal**

Incidents and sanction:

- Lighting of fireworks, Art. 16(2)(c) DR
  - Order the enforcement of the suspended disciplinary measure imposed by the Control, Ethics and Disciplinary Body in its decision its decision of 17 December 2024, i.e. ban from selling tickets to its away-supporters for the next one (1) UEFA club competition match.
  - Fine: 30,000
  - Ban from selling tickets to its away supporters for one (1) additional UEFA club competition match. Said ban from selling tickets to its away supporters is suspended for a probationary period of two (2) years

Incident and sanction:

- Lighting of fireworks, Art. 16(2)(c) DR
  - Fine: €10,000
  - Ban from selling tickets to its away supporters for one (1) UEFA club competition match. Said ban from selling tickets to its away supporters is suspended for a probationary period of two (2) years

**VfB Stuttgart vs. Maccabi Tel-Aviv FC (4:1); 11 December 2025**

**Maccabi Tel-Aviv FC**

Incident and sanction:

- Racist and/or discriminatory behaviour, Art. 14(2) DR
  - Fine: €20,000
  - Ban from selling tickets to its away supporters for one (1) UEFA club competition match. Said ban from selling tickets to its away supporters is suspended for a probationary period of two (2) years

**SC Freiburg vs. FC Salzburg (1:0); 11 December 2025**

**SC Freiburg**

Incident and sanction:

- Lighting of fireworks or any other objects, Art. 16(2)(c) DR
  - Fine: €5,000

**FC Salzburg**

Incident and sanction:

- Serious rough play Mr. Petar Ratkov, Art. 15(1)(d) DR
  - Suspension: two (2) UEFA club competition matches

**FC Midtjylland vs. KRC Genk (1:0); 11 December 2025**

Incidents and sanction:

- Lighting of fireworks, Art. 16(2)(c) DR
  - Fine: €10,000
  - Ban from selling tickets to its away supporters for the next one (1) UEFA club competition match. Said ban from selling tickets to its away supporters is suspended for a probationary period of two (2) years
- Acts of damage caused to the stadium and/or its installations, Art. 16(2)(f) DR
  - Fine: €5,000
