- Transmitting a message that is not fit for a sports event, Art. 16(2)(e) DR
  - Fine: €20,000
- Procedure in case of severe injury to players, Art. 60.02 of the UEFA Conference League Regulations
- Concussion Charter, Annex C of the UEFA Medical Regulations
  - Fine: €10,000
  - Order FC Shakhtar Donetsk to organise a concussion education session with the coaches, the players and the staff in accordance with the Concussion Charter

- Insulting and/or directing abusive language at a match official (Mr. Ángel Roberto Donato Ponce), Art. 15(1)(b) DR
  - Suspension: two (2) UEFA club competition matches
- Improper conduct of the team, Art. 15(4) DR
  - Fine: €2,500
