  - Fine: €30,000
- Crowd disturbances, Art. 16(2)(f) DR
  - Fine: €40,000

- Rough play (Mr. Petros Ioannou), Art. 15(1)(a)(ii) DR
  - Suspension: one (1) UEFA club competition match

- Throwing of objects, Art. 16(2)(b) DR
  - Fine: €3,250

  - Fine: €25,000
  - Partial stadium closure for the next one (1) UEFA club competition match it plays as host club. Said partial stadium closure is suspended for a probationary period of two (2) years
- Unsporting conduct DR (Mr. Jakub Rajek), Art. 15(1)(a)(v) DR
  - Suspension: one (1) UEFA club competition match

**Croatia**

Incidents and sanction:

- Racist and/or discriminatory behaviour, Art. 14(2) DR
  - Fine: €10,000
  - Order the Croatian Football Federation's futsal team to play its next one (1) UEFA representative team competition match it plays as host association behind closed doors. Said match behind closed doors is suspended for a probationary period of one (1) year
- Throwing of objects, Art. 16(2)(b) DR
  - Fine: €6,000
- Crowd disturbances, Art. 16(2)(h) DR
  - Fine: €5,000
- Acts of damage caused to the stadium and/or its installations, Art. 16(2)(f) DR
  - Fine: €2,500
  - Contact the Football Association of Slovenia for the settlement of the damages caused by its supporters
- Improper conduct of the team, Art. 15(4) DR
  - Fine: €1,800
